RECOMMENDING TO THE HEAD OF PROCURING ENTITY THE AWARD OF THE CONTRACTS FOR THE PROCUREMENT OF SERVICE PROVIDER FOR RT-PCR TESTS FOR SEPTEMBER 2022 LICENSURE EXAMINATIONS

WHEREAS, Purchase Request No. 2022-08-075 was received by PRC XII Regional Bids and Awards Committee (RBAC) Secretariat on August 3, 2022 for the Procurement of Service Provider for RT-PCR TESTS FOR SEPTEMBER 2022 LICENSURE EXAMINATION OF PRC Regional Office XII with an ABC of THREE MILLION SIXTY THOUSAND PESOS (PHP 3,060,000.00) only;

WHEREAS, Invitation To Bid No. 2022-002 was posted and published to PhilGEPS website and PRC website in compliance with Republic Act No. 9184 otherwise known as the "Philippine Government Procurement Reform Act," and its 2016 Revised Implementing Rules and Regulations;

WHEREAS, on August 15, 2022, at 2:00pm the scheduled Pre-Bid conference was conducted via video conferencing by the RBAC with the presence of one (1) representative from the prospective bidder namely, Ms. Ming Hyacinth Tan of Davao One World Diagnostic Center, Inc.and one (1) observer from GSP namely, Ms. Russel Fin;

WHEREAS, on August 23, 2022 Bid Bulletin No. 1 was issued and posted in PhilGEPS website by the RBAC to amend the Sec. 1 (Invitation to Bid), Item Number 5 of the bidding documents;

WHEREAS, two (2) possible suppliers viewed the opportunity in the PhilGEPS website namely, BEST DIAGNOSTIC CORPORATION AND PHILIPPINE VISION GROUP (PVG) INC.;

WHEREAS, during the deadline for the SUBMISSION AND RECEIPT OF BIDS and BID OPENING on August 30, 2022, only DAVAO ONE WORLD DIAGNOSTIC CENTER INC. submitted its respective bid.

WHEREAS, Section 30 Rule IX of the Revised Implementing Rules and Regulations of Republic Act No. 9184, known as the Government Procurement Reform Act requires that the preliminary examinations of bids can be conducted by merely

checking the presence and absence of documentary requirements using a non-discretionary "pass/fail" criterion. If a bidder submits the required document, it shall be

rated "passed" for that particular requirement. In this regard, bids that fail to include any requirement or are incomplete or patently insufficient shall be considered as "failed";

WHEREAS, DAVAO ONE WORLD DIAGNOSTIC CENTER INC. having passed the eligibility and technical evaluation, the RBAC opened its financial bid proposal and found out that DAVAO ONE WORLD DIAGNOSTIC CENTER INC. passed the financial component requirement;

WHEREAS, during the post qualification on September 1, 2022 the RBAC and TWG verified, validated, and ascertained all statements made, and documents submitted by the bidding during the submission and opening of bids in its Eligibility, Technical and Financial Envelopes;

WHEREAS, DAVAO ONE WORLD DIAGNOSTIC CENTER INC., passed the post-qualification;

WHEREAS, DAVAO ONE WORLD DIAGNOSTIC CENTER INC. was found to be the Single Calculated and Responsive Bidder with the bid amount of Php 3,060,000.00;

THEREFORE, the PRC Regional Office XII Regional Bids and Awards Committee, RESOLVED, as it is hereby RESOLVED, to recommend to the HOPE of PRC XII to award the contract to DAVAO ONE WORLD DIAGNOSTIC CENTER INC. with an amount of THREE MILLION SIXTY THOUSAND PESOS (PHP 3,060,000.00) only, for the procurement of service provider for RT-PCR TEST for September 2022 Licensure Examination of PRC Regional Office XII, through Competitive Bidding inclusive of VAT and all applicable taxes.

RESOLVED FURTHER, that the Notice of Award shall only be issued upon the receipt of Sub-Allotment Released Order (Sub-ARO) from Central Office
