DECLARATION OF FAILURE OF BIDDING FOR THE SUPPLY AND DELIVERY OF VARIOUS CABINETS WITH APPROVED BUDGET FOR THE CONTRACT OF TWO HUNDRED SEVENTY-FOUR THOUSAND PESOS (₱ 274, 000.00)

WHEREAS, the Regional Bids and Awards Committee (RBAC) published invitation to participate in the Negotiated Procurement under Section 53.9 – Small Value Procurement of the 2016 Revised IRR of Republic Act No. 9184 in the Professional Regulation Commission (PRC) website, in the Philippine Government Electronic Procurement System (PhilGEPS), and in the RBAC Bulletin Board for the project: Supply and Delivery of Various Cabinets with an Approved Budget for the Contract of Two Hundred Seventy-Four Thousand Pesos (₱ 274, 000.00) only.

WHEREAS, pursuant to Annex H, V, D, Item 8.b.ii of the 2016 Revised Implementing Rules and Regulations of RA No. 9184, the Bids and Awards Committee prepared and sent the Request for Quotation to at least three (3) suppliers, contractors or consultants of known qualifications;

WHEREAS, the five (5) prospective suppliers were given copies of Request for Quotation, namely:

- 1. MCM Villamor Marketing Corporation
- 2. ACE Centerpoint
- 3. KCC Property Holdings, Inc.
- 4. KCC Commercial Corporation (KCC Mall of Marbel)
- 5. Peniton Trading

**WHEREAS,** during the submission of bid documents on December 16, 2020, the above-mentioned suppliers submitted their bid proposal;

WHEREAS, during evaluation of bid documents, all of the said suppliers were declared disqualified for failure to submit complete common documents that is part of the eligibility requirements;

WHEREAS, Section 35 Rules X of its IRR provides for the authority of the RBAC to declare a failure of bidding in cases where the bidders fail to comply with the bid requirements as prescribed, to wit:

## Section 35. Failure of Bidding

- 35.1 The BAC shall declare the bidding a failure when:
  - a) No bids are received;
  - b) All prospective bidders are declared ineligible;
  - c) All bids fail to comply with all the bid requirements or post-qualification, or  $x \times x \times x$  (Emphasis supplied)









WHEREFORE, the RBAC RESOLVES, as it hereby RESOLVED, to DECLARE A FAILURE OF BIDDING FOR THE SUPPLY AND DELIVERY OF VARIOUS CABINETS (SECTION 53.9 SMALL VALUE PROCUREMENT) WITH AN APPROVED BUDGET FOR THE CONTRACT OF TWO HUNDRED SEVENTY-FOUR THOUSAND PESOS (₱ 274, 000.00). RESOLVE FURTHER, that the RBAC shall revisit the terms, conditions, and specifications of the project, conduct a rebidding with re-advertisement and/or posting of said project procurement.
