RECOMMENDING TO THE CHAIRMAN OF THE PROFESSIONAL REGULATION COMMISSION FOR HIS APPROVAL THE AWARD OF THE CONTRACT FOR THE SUPPLY AND DELIVERY OF VARIOUS IT EQUIPMENT:

LOT 2 – FORTY-TWO (42) UNITS OF WIDESCREEN LCD

TOUCHSCREEN MONITOR- REBID TO IMAX TECHNOLOGIES, INC. WITH A TOTAL BID AMOUNT OF FIVE HUNDRED TWENTY-TWO THOUSAND THREE HUNDRED NINETY-SIX PESOS (P522,396.00)

WHEREAS, the invitation to apply for eligibility and to bid through Negotiated Procurement under Section 53.9 – Small Value Procurement was posted in the website of the Commission, at the Bids Awards Committee (BAC) Bulletin Board, and in the Philippine Government Electronic Procurement System (PhilGEPS) for the project: Supply and Delivery of Various IT Equipment: Lot 2 – Forty-Two (42) Units of Widescreen LCD Touchscreen Monitor with Approved Budget for the Contract of Six Hundred Twenty-Nine Thousand Nine Hundred Fifty-Eight Pesos (Php629,958.00).

WHEREAS, during the scheduled deadline and submission of bid proposals on November 25, 2020, four (4) bidders submitted their eligibility and technical requirements, namely: IMAX Technologies, Inc. (IMAX), SONKKENS Office Equipment Trading (SONKKENS), Hundredfold Trading (Hundredfold) and The Value Systems Phils., Inc. (Value Systems) submitted their bid quotations.

WHEREAS, on November 25, 2020, during the opening and evaluation of its bids, SONKKENS and Hundredfold failed to comply with the eligibility and technical requirements as they were not able to submit their latest income/business tax returns and their Secretary's Certificate, respectively, thereby receiving failed marks on the evaluation sheet. Meanwhile, IMAX and Value passed the same and submitted the following financial bid quotations:

- 1. IMAX Technologies, Inc. P522,396.00
- 2. The Value Systems Phils., Inc. P625,800.00

WHEREAS, Section 30, Rule IX of the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184, known as the Government Procurement Reform Act, requires that the preliminary examination of the bids be conducted by merely checking for the presence or absence of documentary requirements using a non-discretionary "pass/fail" criterion. If a bidder submits the required document, it shall be rated "passed" for the particular requirement. In this regard, bids that fail to include any requirement or are incomplete or patently insufficient shall be considered as "failed".

WHEREAS, IMAX was declared as the Lowest Calculated and Responsive Quotation.

WHEREFORE, the BIDS AND AWARDS COMMITTEE RESOLVES, as it hereby **RESOLVED**, to recommend to the Chairman of the Professional Regulation Commission for his approval the award of the contract for the project: LOT 2 -FORTY-TWO (42) UNITS OF WIDESCREEN LCD TOUCHSCREEN MONITOR-REBID to IMAX with bid amount of Five Hundred Twenty-Two Thousand Three Hundred Ninety-Six Pesos (Php522,396.00).
