DECLARATION OF FAILURE OF BIDDING FOR THE SUPPLY AND DELIVERY OF VARIOUS CABINETS - REBID WITH APPROVED BUDGET FOR THE CONTRACT OF TWO HUNDRED SEVENTY-FOUR THOUSAND PESOS (₱ 274, 000.00)

WHEREAS, the Regional Bids and Awards Committee (RBAC) published invitation to participate in the Negotiated Procurement under Section 53.9 – Small Value Procurement of the 2016 Revised IRR of Republic Act No. 9184 in the Professional Regulation Commission (PRC) website, in the Philippine Government Electronic Procurement System (PhilGEPS), and in the RBAC Bulletin Board for the project: Supply and Delivery of Various Cabinets with Approved Budget for the Contract of Two Hundred Seventy-Four Thousand Pesos (₱ 274, 000.00) only.

WHEREAS, pursuant to Annex to H, V, D, Item 8bii of the 2016 Revised Implementing Rules and Regulations of RA No. 9184, the Bids and Awards Committee prepared and sent the Request for Quotation to at least three (3) suppliers, contractors or consultants of known qualifications;

WHEREAS, the five (5) prospective suppliers were given copies of Request for Quotation, namely:

- 1. Wilcon Depot
- 2. MCM Villamor Marketing Corporation
- 3. Oliver Doors and Builders Supply Corporation
- 4. KCC Property Holdings, Inc.
- 5. KCC Commercial Corporation (KCC Mall of Marbel)

WHEREAS, on December 28, 2020, only Oliver Doors and Builders Supply Corporation and KCC Mall of Marbel submitted their bid proposals and eligibility requirements;

WHEREAS, during the opening and evaluation of bid documents, the Oliver Doors and Builders Supply Corporation was declared disqualified for failure to submit the Omnibus Sworn Statement and other valid eligibility requirements;

WHEREAS, the KCC Mall of Marbel was declared as Single Calculated Bidder;

WHEREAS, during the conduct of post-qualification, KCC Mall of Marbel failed to meet the technical requirements;

WHEREAS, Republic Act No. 9184 known as the Government Procurement Reform Act, and Section 35 of its Implementing Rules and Regulations provide as follows:

Section 35. Failure of Bidding

- 35.1 The BAC shall declare the bidding a failure when:
 - a) No bids are received;
 - b) All prospective bidders are declared ineligible;
 - c) All bids fail to comply with all the bid requirements or postqualification, or x x x x (Emphasis supplied)

WHEREAS, Section 35.3 of the same IRR provide for the steps and procedure that the BAC should take in case of failure of bidding; $x \times x$

35.3 Based on its findings, the BAC shall revise the terms, conditions, and specifications, and if necessary, adjust the ABC, subject to the required approval and conduct a re-bidding with re-advertisement and/or posting, as provided for in Section 21.2 of the same IRR;

WHEREFORE, the REGIONAL BIDS AND AWARDS COMMITTEE RESOLVES, as it hereby RESOLVED, to DECLARE A FAILURE OF BIDDING for the Supply and Delivery of Various Cabinets-Rebid with Approved Budget For the Contract of Two Hundred Seventy-Four Thousand Pesos (*) 274, 000.00). Resolved futher, that the RBAC shall revert the terms, conditions, and specifications of the project, conduct of a re-bidding with re-advertisement and/or posting of said project procurement, subject to availability of budget.
