

Resolution No. 2020 - 116(A)

DECLARING A FAILURE OF BIDDING FOR THE JANITORIAL SERVICES (2021) FOR THE PRC PAGADIAN REGIONAL AND ZAMBOANGA SATELLITE OFFICE IX

WHEREAS, a Request for Quotation through Small Value Procurement (Section 53.9 Small Value Procurement of RA 9184 of IRR) was published in the PhilGEPS, PRC official website and posted at the premises of PRC Pagadian Regional Office and PRC Zamboanga Satellite Office on November 26, 2020 for the Project: Provision of Janitorial Services (2021) with an Approved Budget for the Contract (ABC) in the amount of **TWO HUNDRED SEVENTY THOUSAND PESOS (270,000.00)**, inclusive of all taxes;

WHEREAS, the Request for Quotation (RFQ No. 2020-01) were also sent to three (3) prospective suppliers, namely: a) Golden Sun Security Agency, Inc., b) SSP Manpower Services and c) PRAC Security Agency;

WHEREAS, during the deadline for submission of bid documents on December 2, 2020, no bids were received;

WHEREAS, Section 35 Rule X of the IRR provides for the authority the BAC to declare of failure of bidding in cases where the bidders fail to comply bid requirements as prescribed, to wit;

Section 35. Failure of Bidding

35.1 The BAC shall declare the bidding a failure when:

- a) **No bids are received** (Emphasis Supplied)

WHEREFORE, in view of the foregoing premises, the **REGIONAL BIDS AND AWARDS COMMITTEE (RBAC) RESOLVES**, as it hereby **RESOLVED**, to **DECLARE A FAILURE OF BIDDING FOR THE PROJECT ENTITLED "PROVISION OF THE JANITORIAL SERVICES (2021)" (SECTION 53.9 SMALL VALUE PROCUREMENT)** with an approved budget for the contract of **TWO HUNDRED SEVENTY THOUSAND PESOS (Php270,000.00)**, inclusive of all taxes. **RESOLVE FURTHER**, that the RBAC will conduct re-bidding with re-advertisement and/or posting of said project with some consideration on the eligibility requirements.
