RECOMMENDING TO THE OIC-REGIONAL DIRECTOR OF THE PROFESSIONAL REGULATION COMMISSION (PRC) REGION IX AS HEAD OF THE PROCURING ENTITY (HOPE), FOR HIS APPROVAL, THE AWARD OF THE CONTRACT FOR THE PROVISION OF SECURITY SERVICES 2020 TO DOUBLE DRAGON SECURITY FORCES AGENCY, INC. WITH A BID AMOUNT OF ONE MILLION FIVE HUNDRED SEVENTY-SEVEN THOUSAND NINETY PESOS AND NINETEEN CENTAVOS (Php.1, 577, 090. 19)

WHEREAS, by virtue of the published invitation to apply for eligibility and to bid through Public Bidding in the website of the Commission and in the Philippine Government Electronic Procurement System (PhilGEPS), and in conspicuous places at the premises of PRC Pagadian Regional Office and Zamboanga Satellite, only Double Dragon Security Forces Agency, Inc. participated in the Public Bidding for the project: Provision of Security Services 2020 with an approved budget for the contract of **One Million Five Hundred Seventy Eight Thousand Fifty Seven Pesos and Fifty Seven Centavos (Php 1,578, 057.57) only**;

WHEREAS, a pre-bid conference was held on July 14, 2020 via virtual meeting between RBAC members and secretariats from Pagadian Regional Office and RBAC members, secretariat together with the two bidders who attended to wit: Double Dragon Security Forces Agency, Inc. and Golden Sun Security Agency Inc. at Office of the Regional Director, Zamboanga Satellite Office.

WHEREAS, Only Double Dragon Security Forces Agency, Inc. purchased the bid documents;

WHEREAS, during the Opening of Bids on July 27, 2020 held at the Office of the Regional Director, Zamboanga Satellite Office, only Double Dragon Security Forces Agency, Inc. submitted their bid containing their eligibility, technical, and financial requirements;

WHEREAS, Section 30, Rule IX of the Revised Implementing Rules and Regulations of Republic Act No. 9184, known as the Government Procurement Reform Act requires that the preliminary examination of bids be conducted by merely checking for the presence or absence of documentary requirements using a no-discretionary "pass/fail" criterion. If a bidder submits the required document, it shall be rated "passed" for that particular requirement. In this regard, bids that fail to include any requirement or are incomplete or patently insufficient shall be considered as "failed";

WHEREAS, Double Dragon Security Forces Agency, Inc. passed eligibility and technical evaluations and the RBAC opened the financial bid proposal with a bid price of **ONE MILLION FIVE HUNDRED SEVENTY-SEVEN THOUSAND NINETY PESOS AND NINETEEN CENTAVOS (Php 1, 577, 090. 19)** and was declared to be the Single Calculated Bidder and was subjected to post qualification process to determine its compliance with all the requirements and conditions for eligibility specified in the bidding documents.

WHEREFORE, the **REGIONAL BIDS AND AWARDS COMMITTEE RESOLVES**, as it hereby **RESOLVED**, to recommend to the OIC-Regional Director as the Head of Procuring Entity of the Professional Regulation Commission Region IX, for his approval, the award of contract for the **PROVISION OF SECURITY SERVICES 2020** to **DOUBLE DRAGON SECURITY FORCES AGENCY, INC.** with the bid amount of **ONE MILLION FIVE HUNDRED SEVENTY-SEVEN THOUSAND NINETY PESOS AND NINETEEN CENTAVOS (Php. 1, 577, 090. 19).**




