WHEREAS, D.E Construction and Supply total bid price is FOUR HUNDRED THOUSAND FIVE HUNDRED FIVE PESOS AND 04/100 ONLY (Php400,505.04). Hence, D.E Construction and Supply was declared as the Single Calculated Bidder.

WHEREAS, during the opening of Bids, the BAC verify, validate and ascertain all statements made, and documents submitted by bidder during the submission and opening of bids in its Eligibility, Technical and Financial Envelopes. D.E Construction and Supply submitted its Original Eligibility and Technical.

WHEREAS, D.E Construction and Supply passed the opening of bids, was declared to be the Single Calculated and Responsive Bidder.

WHEREFORE, the BIDS AND AWARDS COMMITTEE RESOLVES, as it hereby RESOLVED, to recommend to the Regional HOPE of the Professional Regulation Commission, for his approval, the award to D.E Construction and Supply the contract for the Rehabilitation of PRC Zamboanga Satellite Office with the Total Bid Amount of FOUR HUNDRED THOUSAND FIVE HUNDRED FIVE PESOS AND 04/100 ONLY (Php400,505.04).
