

**RECOMMENDING TO THE OFFICER-IN-CHARGE REGIONAL DIRECTOR
OF THE PROFESSIONAL REGULATION COMMISSION CAGAYAN DE ORO
REGIONAL OFFICE X FOR HER APPROVAL THE AWARD OF CONTRACT
FOR THE PROVISION OF SECURITY SERVICES (2020 - 2021) WITH TOTAL
BID AMOUNT OF ONE MILLION FORTY-SIX THOUSAND ELEVEN PESOS
AND SEVENTEEN CENTAVOS (P 1,046,011.17)**

WHEREAS, by virtue of the invitation to apply for eligibility and to bid through Public Bidding in the website of the Commission and in the Philippine Government Electronic Procurement System (PhilGEPS), ACD Investigation Security Agency (ACDISA), Inc. and BWPSSI Security Agency (Blackwater Philippines Security Solutions), Inc. participated in the Public Bidding for the Security Services (2020 – 2021) of PRC Cagayan de Oro Regional Office X with the APPROVED BUDGET FOR THE CONTRACT OF **ONE MILLION TWO HUNDRED ONE THOUSAND PESOS (P 1,201,000.00)**.

WHEREAS, both bidders complied with the registration requirements of the Bids and Awards Committee.

WHEREAS, a pre-bid conference for the project was held on July 29, 2020 at the Event Center, 2nd floor, Limketkai Center, Cagayan de Oro City, which was attended by ACD Investigation Security Agency (ACDISA), Inc. and BWPSSI Security Agency (Blackwater Philippines Security Solutions), Inc.

WHEREAS, during the opening of bid documents on August 12, 2020 held at the Event Center, 2nd floor, Limketkai Center, ACD Investigation Security Agency (ACDISA), Inc. and BWPSSI Security Agency (Blackwater Philippines Security Solutions), Inc., submitted its respective eligibilities, technical and financial requirements. And it was found out that ACD Investigation Security Agency (ACDISA), Inc. failed to attach Sections IV and V of the bidding documents, the General Conditions and Special Conditions of Contract respectively. Hence, ACD Investigation Security Agency (ACDISA), Inc. was declared as "ineligible".

WHEREAS, BWPSSI Security Agency (Blackwater Philippines Security Solutions), Inc. was declared to be the Single Calculated Bidder and was subjected to post qualification process to determine its compliance with all the requirements and conditions for eligibility specified in the bidding documents.

WHEREAS, a site inspection was conducted on August 14, 2020 for post qualification.




