## RECOMMENDING TO THE REGIONAL DIRECTOR OF THE PROFESSIONAL REGULATION COMMISSION REGIONAL OFFICE NO. 02 THE AWARD OF THE CONTRACT FOR THE PROJECT ENTITLED "SUPPLY, DELIVERY AND INSTALLATION OF VARIOUS TYPES OF AIRCONDITIONING UNITS FOR PRC TUGUEGARAO REGIONAL OFFICE", TO CAGAYAN APPLIANCE CENTER

WHEREAS, the invitation to apply for eligibility and to bid through Negotiated Procurement (Section 53.9 Small Value Procurement) was posted in the Philippine Government Electronic Procurement System (PhilGEPS), website of the Commission and in the premises of PRC Tuguegarao Regional Office for the project: Supply, Delivery and Installation of Various Types of Air Conditioning Units for PRC Tuguegarao Regional Office – Rebid with an Approved Budget for the Contract (ABC) of Two Hundred Fifty Thousand Pesos (₱250,000.00);

WHEREAS, pursuant to Annex H, V, D, Item 8.b.ii of the 2016 Revised Implementing Rules and Regulations of RA No.9184, the Bids and Awards Committee prepared and sent the Request for Quotation to at least three (3) suppliers, contractors or consultants of known qualifications;

WHEREAS, three (3) prospective suppliers were given copies of Request for Quotation, namely:

- 1. Cagayan Appliance Center
- 2. K-Service
- 3. S & J Marketing

WHEREAS, during the opening of bids for the above-titled project which was held on September 4, 2019; three o' clock in the afternoon at the PRC Regional Office No, 02, Regional Government Center, Carig Sur, Tuguegarao City, Cagayan, only Cagayan Appliance Center responded to the Invitation to Bid and submitted its corresponding technical and financial documents

WHEREAS, after due evaluation of the documents submitted by Cagayan Appliance Center, the same was declared eligible to participate in the bidding process. Consequently, after opening the financial document submitted, it was found out that Cagayan Appliance Center's financial bid proposal is Two Hundred Forty-Five Thousand Four Hundred Pesos (₱245,400.00).



WHEREAS, Cagayan Appliance Center, being the lone bidder and having offered a bid below the Approved Budget of the Contract, is declared as the Single Calculated Responsive Bidder.

WHEREFORE, the REGIONAL BIDS AND AWARDS COMMITTEE RESOLVES, as it hereby RESOLVED, to recommend the award of the contract for the project entitled ""SUPPLY, DELIVERY AND INSTALLATION OF VARIOUS TYPES OF AIRCONDITIONING UNITS FOR PRC TUGUEGARAO REGIONAL OFFICE" TO CAGAYAN APPLIANCE CENTER with total bid amount of TWO HUNDRED FORTY-FIVE THOUSAND FOUR HUNDRED PESOS (**P**245,400.00).
