1. Section I Invitation to Bid shall now be read as follows:

The **PROFESSIONAL REGULATION COMMISSION – CENTRAL OFFICE (PRC-CO)**, through the **Government of the Philippines (GOP)** **General Appropriations Act (GAA) of 2024 (R.A. No. 11975 dated December 25, 2023)** intends to apply the sum of **ONE MILLION FORTY-FOUR THOUSAND PESOS (Php 1,044,000.00)** being the Approved Budget for the Contract (ABC) to payments under the contract for the **Procurement of Supply and Delivery of Purified Drinking Water with Free Use of Hot and Cold Water Dispenser under Multi-Year Contractual Authority (MYCA) for FY2024-FY2026 of the PRC – CO/ ITB No. 2024-13**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
