Resolution No. 13 Series of 2023

ADOPTING THE FINANCIAL AND SUSTAINABILITY REPORTING STANDARDS COUNCIL AMENDMENTS AND PRONOUNCEMENTS

WHEREAS, the Financial and Sustainability Reporting Standards Council (FSRSC) has approved and submitted hereunder pronouncement to the Professional Regulatory Board of Accountancy (Board) for approval:

- 1. Issuance of PFRS amendments
 - a. Amendments to PFRS 9 Financial Instruments, PAS 39
 Financial Instruments: Recognition and Measurement, PFRS 7
 Financial Instruments: Disclosures, PFRS 4 Insurance Contracts and PFRS 16 Leases, Interest Rate Benchmark Reform—Phase 2
 - b. Amendments to PAS 1 Presentation of Financial Statements, Non-current Liabilities with Covenants
- 2. Issuance of Philippine Interpretations Committee (PIC) pronouncements
 - a. PIC Q&A No. 2019-01 (Amended August 2022): Accounting for service charges under PFRS 15, Revenue from Contracts with Customers
 - b. PIC Q&A No. 2022-05: Accounting by a Representative Office of Remittances from its Foreign Head Office

WHEREAS, after study and review of the provisions of the above-stated pronouncement as adopted by the FSRSC, the Board finds them to be well-taken and instructive for compliance by practicing Certified Public Accountants.

WHEREFORE, the Board RESOLVES as it is hereby RESOLVED, to adopt the above-stated pronouncement as part of the Philippine Accounting Standards.

RESOLVED FURTHER, that this Resolution and the above-stated pronouncement shall take effect after fifteen (15) days following its publication in the Official Gazette or in any newspaper of general circulation in the Philippines.
