The PROFESSIONAL REGULATION COMMISSION – CENTRAL OFFICE (PRCCO), through the Government of the Philippines (GOP) General Appropriations Act (GAA) of 2024 (R.A. No. 11975 dated December 25, 2023), FY 2023 Continuing Appropriations and Multi-Year Contract Authority No. MYCA-BMB-B-23-0000134 intends to apply the sum of TWENTY-TWO MILLION NINETY-NINE THOUSAND FIVE HUNDRED THIRTY-FOUR PESOS and SIXTY-NINE CENTAVOS (Php 22,099,534.69) being the Approved Budget for the Contract (ABC) to payments under the contract for the Procurement of Courier Services of the Professional Regulation Commission (PRC) – Central Office for CY 2024-2026 / ITB No. 2024-29. Bids received in excess of the ABC shall be automatically rejected at bid opening.
