Please be advised that **similar contracts** shall now refer to contracts for **PROCUREMENT OF SUPPLY, PRINTING, AND DELIVERY OF PRE-PRINTED MATERIALS/FORMS**, hence the following modifications to the bidding documents:

1. Section III. Bid Data Sheet. ITB Clause 5.3. A. shall now be read as:

Similar contracts shall refer to contracts for **PROCUREMENT OF SUPPLY, PRINTING, AND DELIVERY OF PRE-PRINTED MATERIALS/FORMS**.

2. Section VIII. Checklist of Technical and Financial Documents. Item Number 3 shall now be read as:

Statement identifying the Bidder's Single Largest Completed Contract (SLCC) similar to the contract to be bid within the period **from January 2020 prior to the date of submission and opening of bids, equivalent to at least 50% of the ABC, which is EIGHT HUNDRED EIGHTY-EIGHT THOUSAND TWO HUNDRED SIXTY-FOUR PESOS (Php 888,264.00) only.**

For this purpose, similar contracts shall refer to contracts for **PROCUREMENT OF SUPPLY, PRINTING, AND DELIVERY OF PRE-PRINTED MATERIALS/FORMS**.

The two statements required shall indicate for each contract, the following:

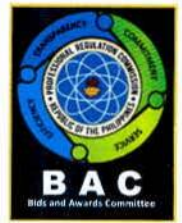
- i. Name of the contract;
- ii. Date of the contract;
- iii. Contract duration;
- iv. Owner's name and address;
- v. Kinds of goods/services;
- vi. For Statement of Ongoing Contract(s) -amount of contract and value of outstanding contract;
- vii. For Statement of SLCC – amount of completed contract, adjusted by the Bidder to current prices using PSA's consumer price index, if necessary for the purpose of meeting the SLCC requirement;
- viii. Date of delivery; and
- ix. End User's acceptance or Official Receipt(s) or Sales Invoice issued for the contract, if completed, which shall be attached to the statement

Kindly submit this Bulletin with the other technical eligibility documents (inside the TECHNICAL COMPONENT ENVELOPE).
