



Please be advised of the following modifications/amendments to the **Bidding Documents.**

1. The provision below shall be added to Section VI. Schedule of Requirements:

"17. Bidder warrants that its owner, or any of its officials, has not offered and will not offer any sum of money or non-financial favor to any members of the Bids and Awards Committee (BAC), or any official or employee of the Commission, in return for favorable consideration of the subject bid; and acknowledge and agree that such act of offer constitutes the criminal offense of bribery for which the owner of the company and the company shall be liable for sanctions under existing laws and outright disqualification of the company from bidding."

2. Section VII. Technical Specifications shall now be read as follows:


