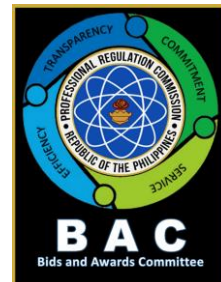

Please be advised of the following modification/amendments to the Bidding Documents.

1. Section I Invitation to Bid Clause 1 a shall now read as follows:

ITB Clause	
1	The PROFESSIONAL REGULATION COMMISSION (PRC) , through the Government of the Philippines (GOP) , Continuing Appropriations of Year 2022 , intends to apply the total sum of Four Million Eighteen Thousand Pesos (Php4,018,000.00) being the Approved Budget for the Contract (ABC) to payments under the contract for the Procurement of Desktop Computers / ITB No. 2023-26 . Bids received in excess of the ABC shall be automatically rejected at bid opening.

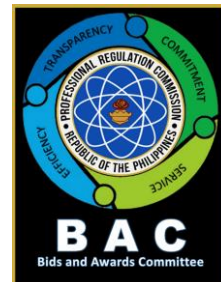

3. Section VIII Checklist of Technical and Financial Documents Clause 3 shall now read as follows:

Section VIII Clause	
3	<p>The statement identifying the Bidder's Single Largest Completed Contract (SLCC) similar to the contract to be bid within the period from January 2019 prior to the date of submission and opening of bids, equivalent to at least 50% of the ABC, which is <u>₱2,009,000.00</u> only.</p> <p><i>For this purpose, similar contracts shall refer to contracts for the Procurement of Desktop Computers.</i></p> <p>The two statements required shall indicate for each contract, the following:</p> <ol style="list-style-type: none">Name of the contract;Date of the contract;Contract duration;Owner's name and address;Kinds of goods/services;For Statement of Ongoing Contract(s) -amount of contract and value of outstanding contract;For Statement of SLCC – amount of completed contract, adjusted by the Bidder to current prices using PSA's consumer price index, if necessary for the purpose of meeting the SLCC requirement;Date of delivery; and <p>End User's acceptance or Official Receipt(s) or Sales Invoice issued for the contract, if completed, which shall be attached to the statements.</p>
