- 3. Examinees are required to wear the following attire every examination day:

Male Examinees - Tucked-in white polo shirt with collar (without any seal,

logo or mark), decent pants or slacks

Female Examinees - Tucked-in white blouse or shirts with collar (without any

seal, logo or mark), decent pants, slacks or skirt,

pony-tailed long hair

- 4. Bring the following on the examination day:
 - a. Notice of Admission
 - b. Official Receipt
 - c. Two or more pencils (No. 2)
 - d. One (1) piece Long Brown Envelope
 - e. One (1) piece Long Transparent (non-colored) Plastic Envelope (for keeping your valuables and other allowed items)
- 5. The following are STRICTLY PROHIBITED inside the examination premises/rooms:
 - a. Books, notes, review materials, and other printed materials containing coded data/information/formula.
 - b. CALCULATORS.
 - c. SMART WATCHES, CELLULAR PHONES, EAR PLUGS, TRANSMITTTERS, PORTABLE COMPUTERS and other electronic gadgets/devices which may be used for communication purposes.
 - d. Bags of any kind (place your documents inside the transparent/plastic envelope)
 - e. Other examination aides not stated in this program.
