

**CONTRACT FOR THE PROVISION OF SECURITY SERVICES 2019**

**KNOW ALL MEN BY THESE PRESENTS:**

This Contract made and entered into by and between:

**PROFESSIONAL REGULATION COMMISSION (PRC)**, an agency of the National Government, created pursuant to Republic Act No. 8981, with principal office address at P. Paredes Street, Sampaloc, Manila, herein represented by its OIC Regional Director of PRC Cagayan de Oro Regional Office X, **MS. JULIE L. SABALZA**.

**ACD INVESTIGATION SECURITY AGENCY**, a corporation duly organized and existing under the laws of the Republic of the Philippines, hereinafter referred to as **ACDISA** with principal address at 961 Quezon Boulevard, Davao City herein represented by its Incorporator, **MS. AMY DILLA - GRABATO**.

**WITNESSETH THAT:**

**WHEREAS**, PRC invited Bids for the Provision of Security Services for the year 2019 for PRC Cagayan de Oro Regional Office X, and has accepted the Bid of **ACD Investigation Security Agency** for the supply of goods and services in the sum of **TWO MILLION ONE HUNDRED THIRTY SIX THOUSAND FIVE PESOS AND FIFTY TWO CENTAVOS ONLY (P2,136,005.52)**. (Hereinafter called "the Contract Price").

**WHEREAS**, upon evaluation and recommendation of the Regional Bids and Awards Committee of PRC Cagayan de Oro Regional Office X, and approved by the Commission, **ACDISA** was declared to be the single calculated and responsive bidder for the project Provision of Security Services 2019.

**NOW THEREFORE**, for and in consideration of the above mentioned premises and of the mutual obligations, duties and responsibilities, as well as the terms and conditions hereinafter set forth, **PRC** and **ACDISA** have agreed as follows:

3. In consideration of the payments to be made by the **PRC**, **ACDISA** hereby agrees to provide the services in conformity in all respects and purposes with the provisions of this Contract.




