All Examinees are Required to bring the following:

- Notice of Admission
- One (1) piece metered-stamped window mailing envelope
- Two (2) or more pencils (No. 2)
- Ball pens with <u>BLACK ink only</u>
- One (1) piece long brown envelope
- One (1) piece transparent plastic envelope (for keeping your valuables and other allowed items).
- NON-PROGRAMMABLE CALCULATORS (Please refer to Commission Resolution No. 1809-2024 or the "Updated list of Non-Programmable Calculators Allowed to be used in the Licensure Examinations"). Basic calculators (those without scientific functions) are also allowed.
- NOTE: ONLY ONE BASIC CALCULATOR SHALL BE ALLOWED INSIDE THE EXAMINATION ROOM. CALCULATORS SHALL BE INSPECTED AND HAVE TO BE RESET BEFORE THE START OF THE EXAMINATION.
  - · Food and water. It must be in a transparent container.
    - NOTE: Distribution of food or drinks by schools, review centers, coexaminees, or any other groups is not allowed on the testing center premises, even during break times











## **IMPORTANT REMINDERS**

- Examinees are prohibited to bring any PROGRAMMABLE CALCULATORS or calculators with embedded functions especially CASIO FX991ES and CASIO FX-991ES plus.
- Examinees are not allowed to bring the following inside the testing centers: APPLE, SAMSUNG AND OTHER SMART WATCHES, CELLULAR PHONES, EAR PLUGS, TRANSMITTERS, PORTABLE COMPUTERS, BLUETOOTH AND OTHER ELECTRONIC GADGETS/DEVICES WHICH MAY BE USED TO STORE OR RETRIEVE DATA/INFORMATION AND/OR TO COMMUNICATE FOR WHATEVER PURPOSES
- Books, notes, review materials, and other printed materials containing coded data/information/formula.
- Bags of any kind (place your documents inside the transparent/plastic envelope)
- Bringing the above items inside the testing venues will be considered as CHEATING or an ACT OF DISHONESTY. If an examinee is found guilty, his/her examination papers shall be cancelled and shall either be suspended or debarred from taking future examination.
- Report to the school/building assignment before 6:30am on the first day of examination to verify your room and seat number. Be punctual. Late examinees will not be admitted.
- Examinees are required to wear the following attire every examination day:

  - e. Other examination aides not stated in this program.
