

CONTRACT FOR THE SECURITY SERVICES 2019

KNOW ALL MEN BY THESE PRESENTS:

This Contract made and entered into by and between:

PROFESSIONAL REGULATION COMMISSION – TACLOBAN REGIONAL OFFICE, an agency of the National Government, hereinafter referred to as **PRCTAC RO**, with office address at 2nd Floor Uytingkoc Building, Senator Enage St., Tacloban City, represented by its OIC – Regional Director, **Mr. NARCIVAL RANDIE Z. TAQUIQUI**;

-and-

VISION SECURITY SERVICES, INC., a corporation engaged in the business of providing security services, duly organized and existing under and by virtue of the laws of the Republic of the Philippines, hereinafter referred to as **VISION** with principal address at Poticano Compound, Maharlika Highway, Brgy. 95 Caibaan, Tacloban City, Leyte 6500, herein represented by its General Manager, **Mr. RICARDO G. VALUIS, JR.**

WITNESSETH THAT:

WHEREAS, PRCTAC RO invited Bids for the Security Services for the year 2019 as described and enumerated in Section VI or the Schedule of Requirements, and has accepted the Bid of **VISION** for the supply of goods and services in the sum of **SEVEN HUNDRED SEVEN THOUSAND NINE HUNDRED THIRTY-TWO PESOS AND FORTY-FOUR CENTAVOS (₱707,932.44)**. (Hereinafter called "the Contract Price");

WHEREAS, upon evaluation and recommendation of the Regional Bids and Awards Committee of PRCTAC RO, and approved of the OIC – Regional Director, **VISION** was declared to be the lowest calculated and responsive bidder for the project Security Services 2019 as described and enumerated in Section VI or the Schedule of Requirements;

NOW THEREFORE, for and in consideration of the above-mentioned premises, and of the mutual obligations, duties and responsibilities, as well as the terms and conditions hereinafter set forth, **PRCTAC RO** and **VISION** have agreed as follows:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents, herein attached as Annexes "A-G" shall be deemed to form and be read and construed as part of this Agreement, viz:
 - A. The Bid Form and the Price Schedule submitted by **VISION**;
 - B. The Schedule of Requirements acknowledged by **VISION**;
 - C. The Technical Specifications acknowledged by **VISION**;
 - D. The General Conditions of Contract;
 - E. The Special Conditions of Contract;
 - F. PRCTAC RO's Notification of Award; and
 - G. The Affidavit of Undertaking executed by **VISION**.
3. That **VISION** shall regularly and closely check the Security Guards in the performance of their duties and responsibilities and to ensure that they are

properly discharging their duties and responsibilities and not committing any act(s) prejudicial to the interest of **PRCTAC RO**.

4. In consideration of the payments to be made by **PRCTAC RO, VISION** hereby agrees to provide the services in conformity in all respects and purposes with the provisions of this Contract.
5. This contract shall be effective and be in force from May 1, 2019 to April 30, 2020 unless sooner terminated for violation of any of the stipulations provided herein, or on account of any valid and just causes in which case the contract shall be automatically considered without force and effect after fifteen (15) calendar days from service of a Notice of Termination of Contract to the other contracting party.






