**CONTRACT AGREEMENT**

**FOR THE**

**PROCUREMENT OF SERVICE PROVIDER FOR RT-PCR TESTS FOR SEPTEMBER 2022  
LICENSURE EXAMINATIONS OF PROFESSIONAL REGULATIONS COMMISSION  
REGIONAL OFFICE XII (FOR PROFESSIONAL TEACHERS AND VETERINARY  
MEDICINE)**

THIS AGREEMENT made the \_\_\_\_ day of September 2022 between **PROFESSIONAL REGULATION COMMISSION REGIONAL OFFICE XII (PRC RO XII)** of the Philippines (hereinafter called "the Entity") of the one part and **DAVAO ONE WORLD DIAGNOSTIC CENTER, INC. (ONE WORLD)** of Davao City, Philippines (hereinafter called "the Service Provider") of the other part;

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly **Procurement of Service Provider for September 2022 Licensure Examinations of PRC RO XII (specifically for Professional Teachers and Veterinary Medicine)** and has accepted a Bid by the Service Provider for the supply of those goods and services in the sum of **THREE MILLION SIXTY THOUSAND PESOS (PHP3,060,000.00)** (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, viz.:
  - i. Philippine Bidding Documents (PBDs);
    - a. Schedule of Requirements;
    - b. Technical Specifications;
    - c. General and Special Conditions of Contract; and
    - d. Supplemental/Bid Bulletin No. 1, s. 2022
  - ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;
  - iii. Performance Security;
  - iv. Notice of Award of Contract; and the Bidder's conforme thereto; and
  - v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. **Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.**

3. In consideration for the sum of **THREE MILLION SIXTY THOUSAND PESOS (PHP3,060,000.00)**, **DAVAO ONE WORLD DIAGNOSTIC CENTER, INC. (ONE WORLD)** agrees to *provide the services for RT-PCR Tests for September 2022 Licensure Examinations of PRC RO XII* in accordance with its Bid.
4. In view of change in the schedule of licensure examination for Professional Teachers, the new schedule RT-PCR testing are as follows:

Licensure Examination	Date of RT-PCR Testing	Venue
Veterinary Medicine	September 22, 2022	Koronadal City
Professional Teachers	September 27-28, 2022	Koronadal City
Professional Teachers	September 29, 2022	Kidapawan City

Details on the number of individuals to be swabbed per location/venue shall be communicated by the Entity to the Service Provider.

Any further changes in the schedule shall be communicated by the Entity to the Service Provider at least two days before the stated schedule above.

5. The Entity may terminate the contract whenever RT-PCR testing may no longer be required under any of the following legal basis:
  - a. The Proclamation on State of Public Health Emergency due to COVID19 expired or is lifted.
  - b. The Professional Regulation Commission, Department of Health, and Philippine National Police Joint Administrative Order No. 2012-01 dated July 28, 2021 (Revised Standard Guidelines on the Strict Observance of Health Protocols in the Conduct of Licensure Examinations During Public Health Emergency and/or Pandemic) is amended.
6. The **PRC RO XII** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
