This Contract made and entered into by and between:

The **PROFESSIONAL REGULATION COMMISSION – RO XI (PRC – RO XI)**, an instrumentality of the Republic of the Philippines, organized and existing under the laws of the Republic of the Philippines, hereinafter referred to as "the Procuring Entity", with office address at Calamansi St., corner 1<sup>st</sup> St., Juna Subdivision, Matina, Davao City represented by its Regional Director, **RAQUEL R. ABRANTES**;

**DAVAO ONE WORLD DIAGNOSTIC CENTER, INC.**, a corporation duly organized and existing under the laws of the Republic of the Philippines, hereinafter referred to as "the Supplier", with business address at Km. 5 Guadalupe Village, 74-A Matina Crossing, Davao City, represented by **MS. THERESA T. GOTAMCO**.

**WITNESSETH**

**WHEREAS**, **PRC - RO XI** invited **DAVAO ONE WORLD DIAGNOSTIC CENTER, INC.**, being technically, legally and financially capable supplier, to participate the procurement project for the Procurement of RT-PCR Test Service for PRC - RO XI Examination Personnel for the conduct of Licensure Examination for Professional Teachers on January 30, 2022 and has accepted the submitted financial proposal with an amount of **One Million Two Hundred Twelve Thousand One Hundred Pesos (Php1,212,100.00)**, hereinafter called "the Contract Price".

  - G. Omnibus Sworn Statement; and
  - H. Notice of Award
3. In consideration of the payments to be made by the **PRC - RO XI**, **DAVAO ONE WORLD DIAGNOSTIC CENTER, INC.** hereby agrees to provide the goods and




services and to remedy defects therein in conformity, in all respects, with the provisions of this Contract.


