BRING THE FOLLOWING ON THE DAY/S OF THE EXAMINATION:

#### NOTE:

- Examinees shall bring their own pens and pencils. Borrowing from a seatmate is strictly not allowed.
- Only basic calculators are allowed. A basic calculator is one which only contains the keys for the basic functions (+, -, x and /). It may also have the memory keys (M+, M-, MR and MC). Calculators with TAX functions are also allowed.
- All personal belongings of the examinees shall be surrendered to the proctor and shall be placed in a secured space within the examination venue.
- The rules on the conduct of bodily search, inspection of personal belongings of the examinees, and the seizure/confiscation of prohibited items during the licensure exam (Annex A of PRC MO No. 57 s. 2020) shall be strictly observed.

Examinees shall report to the school/building assignment not later than 5:30 A.M. Be punctual. Late examinees will not be admitted.

Examinees are required to wear the following attire every examination day:

- a. Male examinees Tucked-in white polo or shirt with collar (without any seal, logo or mark);
  - Decent pants or slacks
- b. Female examinees Tucked-in white blouse or shirt with collar (without any seal, logo or mark);
  - Decent pants, slacks or skirts

Examinees must be well-groomed, with hair properly clipped and/or pony tailed.

# **Individually Packed Lunch, Snacks and Drinks**

Examinees and examination personnel shall bring their own meals (pre-packed meal/snack and drink) to be eaten during breaks, on their assigned seats. Face mask and face shields will only be removed when taking meals or drinks.


The use of polyethylene terephthalate (PET) or plastic bottles for water shall be avoided in observance of the solid waste management initiatives of the LGU and the partner schools.

Note: Schools/Review Centers/Co-examinees or any groups are NOT allowed to distribute or sell food and drinks outside or inside the testing center premises. Food Deliveries are STRICTLY NOT ALLOWED. School Canteens are not allowed to sell food.

## LICENSURE EXAMINATIONS FOR PRC BUTUAN CITY

The following are **PROHIBITED** inside the examination premises/rooms:

- Books, notes, review materials, and other printed materials containing coded data/information/formula
- Calculators that can automatically carry out a sequence of operations under control of a stored program, much like a computer and/or with audio-visual features, and/or capable of external communication or internet connectivity fall under programmable calculators.
- APPLE, SAMSUNG AND OTHER SMART WATCHES, CELLULAR PHONES, BLUETOOTH, EAR PLUGS, TRANSMITTERS, PORTABLE COMPUTERS and other electronic gadgets/devices which may be used to store or retrieve data/information and/or to communicate for whatever purpose.
- Bags of any kind (ladies bag, shoulder bags, attaché case, backpacks, etc.)
- · Other examination aids not stated in this program.
