IMPORTANT REMINDERS

- Bringing the above items inside the testing venues will be considered as CHEATING or an ACT OF DISHONESTY. If an examinee is found guilty, his/her examination papers shall be cancelled and shall either be suspended or debarred from taking future examination.
- Report to the school/building assignment before 6:30am on the first day of examination to verify your room and seat number. **Be punctual. Late examinees will not be admitted.**
- Examinees are required to wear the following attire every examination day:
 - **Male Examinees** - White polo shirt with collar, tucked-in (without any seal, logo or mark) Decent pants or slacks


