TOYOTA MARILAO BULACAN INC., hereinafter referred to as TOYOTA MARILAO, a corporation duly organized and existing under the laws of the Republic of the Philippines, with principal address at Lot 1505 McArthur Highway, Abangan Sur, Marilao Bulacan, herein represented by its Marketing Professional, MR. GERALD DE JESUS SUÑIGA.

WITNESSETH THAT:

WHEREAS, PRC invited bids for the Procurement of Motor Service Vehicles: Lot 1 – Procurement of Four (4) Passenger Vans, and has accepted the bid of TOYOTA MARILAO for the supply of goods in the amount of EIGHT MILLION FIVE HUNDRED NINETY SIX THOUSAND PESOS (Php8,596,000.00) only. (Hereinafter called "the Contract Price").

- clarifications on the bid), including corrections to the bid resulting from the Procuring Entity's bid evaluation;
- B. The Schedule of Requirements acknowledged by the TOYOTA MARILAO;
- C. The Technical Specifications acknowledged by the TOYOTA MARILAO;
- D. The General Conditions of Contract acknowledged by the TOYOTA MARILAO;
- E. The Special Condition of Contract acknowledged by the TOYOTA MARILAO;
- F. The Performance Security; and
- G. PRC's Notice of Award.
- In consideration of the payments to be made by the PRC, TOYOTA MARILAO hereby agrees to provide the goods and to remedy defects therein in conformity in all respects with the provisions of this Contract.
- 4. PRC hereby covenants to pay the TOYOTA MARILAO in consideration of the provision of the services and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the contract.
