This Contract made and entered into by and between:

TOYOTA MARILAO BULACAN INC., hereinafter referred to as TOYOTA MARILAO, a corporation duly organized and existing under the laws of the Republic of the Philippines, with principal address at Lot 1505 McArthur Highway, Abangan Sur, Marilao Bulacan, herein represented by its Marketing Professional, MR. GERALD DE JESUS SUÑIGA.

## WITNESSETH THAT:

WHEREAS, PRC invited bids for the Procurement of Motor Service Vehicles: Lot 3 – Procurement of One (1) Car (Sedan or Hatchback), and has accepted the bid of TOYOTA MARILAO for the supply of goods in the amount of ONE MILLION ONE HUNDRED FORTY NINE THOUSAND PESOS (Php1,149,000.00) only. (Hereinafter called "the Contract Price").

- 4. PRC hereby covenants to pay the TOYOTA MARILAO in consideration of the provision of the services and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the contract.
