WITNESSETH THAT:

WHEREAS, PRC invited bids for the Procurement of Motor Service Vehicles: Lot 4 – Procurement of Twenty Four (24) AUV or CUV, and has accepted the bid of TOYOTA MARILAO for the supply of goods in the amount of TWENTY NINE MILLION FOUR HUNDRED THIRTY NINE THOUSAND PESOS (Php29,439,000.00) only.
