The payment of the services rendered shall be made within 30 days upon issuance of the Statement of Account (SOA)/Billing Statement and on a bank-to-bank basis.

Failure to comply with the Terms of Reference and conditions of the Contract will result in the payment of the corresponding penalties/liquidated damages in the amount equivalent to 10% of the contract price by the WINNING SERVICE PROVIDER.

Delivery Period: The delivery of sealed boxes of test booklets, examination supplies, and forms via diplomatic pouch at the <u>DFA Records</u>, Roxas Boulevard, Manila, Philippines shall be on **May 30, 2024**.

The Winning Bidder shall transmit to the different Embassies/Consulate of the approved examination venues within seven (7) days upon turn over by the DFA to the Winning Bidder.

- Compliance with the statements must be supported by evidence in a Bidders Bid and cross-referenced to that evidence. Evidence shall be in the form of manufacturer's un-amended sales literature, unconditional statements of specification and compliance issued by the manufacturer, samples, independent test data etc., as appropriate.
- A statement that is not supported by evidence or is subsequently found to be contradicted by the evidence presented will render the Bid under evaluation liable for rejection.
- 3. A statement either in the Bidders statement of compliance or the supporting evidence that is found to be false either during Bid evaluation, post-qualification or the execution of the Contract may be regarded as fraudulent and render the Bidder or supplier liable for prosecution subject to the provisions of ITB Clause.
