

**CONTRACT FOR THE PROCUREMENT OF VARIOUS IT EQUIPMENT:  
LOT 1 FORTY-FOUR (44) UNITS OF LASER COLORED PRINTER**

**KNOW ALL MEN BY THESE PRESENTS:**

This Contract made and entered into by and between:

**PROFESSIONAL REGULATION COMMISSION**, an agency of the National Government, hereinafter referred to as **PRC**, with principal office address at P. Paredes, (former Morayta St.), Sampaloc, Manila, represented by its Chairman, **HON. TEOFILO S. PILANDO, JR.**;

- and -

**BUSINESS MACHINES CORPORATION (BISMAC)** a corporation duly organized and existing under the laws of the Republic of the Philippines, with principal address at Carson Bldg. Orense cor. Del Carmen St., Guadalupe Nuevo Makati City, herein represented by its Government Coordinator, **MS. MYLENE PALALAY**.

**WITNESSETH THAT:**

**WHEREAS**, PRC invited bids for the Procurement of Various IT Equipment: Lot 1 – Forty-Four (44) Units of Laser Colored Printer, and has accepted the bid of **BISMAC** for the supply of goods and services in the amount of **ONE MILLION EIGHT HUNDRED TWENTY-EIGHT THOUSAND FIVE HUNDRED EIGHTY PESOS (Php1,828,508.00)** only. (Hereinafter called "the Contract Price").

**WHEREAS**, upon evaluation and recommendation of the Bids and Awards Committee, and approval of the Commission, **BISMAC** was declared to be the Single Calculated and Responsive Bidder for the project: Procurement of Various IT Equipment: Lot 1 – Forty-Four (44) Units of Laser Colored Printer.

**NOW, THEREFORE**, for and in consideration of the abovementioned premises and of the mutual obligations, duties and responsibilities, as well as the terms and conditions hereinafter set forth, **PRC** and **BISMAC** have agreed as follows:


1. The words, phrases and expression in this Agreement shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents, herein attached as "Annexes A-G", shall be deemed to form part of this Agreement and be read and construed as follows:
  - A. The Supplier's Bid, including the Technical and Financial Proposal, and all other documents/statements submitted (e.g. bidder's response to clarifications on the bid), including corrections to the bid resulting from the Procuring Entity's bid evaluation;
  - B. The bidder is required to supply and deliver the Forty-Four (44) Units of Laser Colored Printer within Forty-Five (45) calendar days upon receipt of Notice to Proceed stated in the Schedule of Requirements as part of Bidding Documents duly acknowledged by the **BISMAC**;

- C. The Technical Specifications acknowledged by the **BISMAC**;
  - D. The General Conditions of Contract acknowledged by the **BISMAC**;
  - E. The Special Condition of Contract acknowledged by the **BISMAC**;
  - F. The Performance Security; and
  - G. PRC's Notice of Award.
3. In consideration of the payments to be made by the **PRC, BISMAC** hereby agrees to provide the goods and to remedy defects therein in conformity in all respects with the provisions of this Contract.
4. **PRC** hereby covenants to pay the **BISMAC** in consideration of the provision of the services and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the contract.

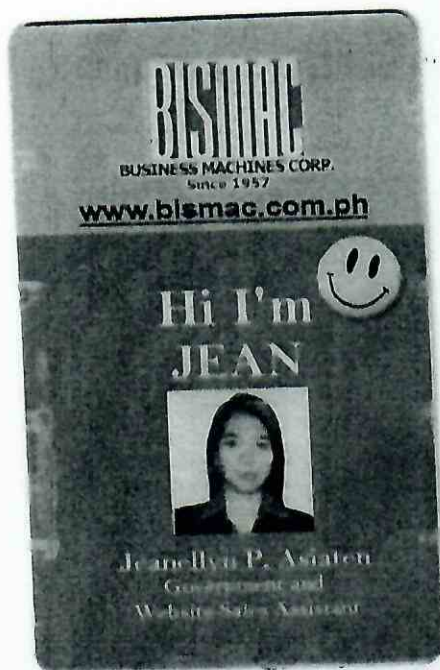
