Resolution No. 2019 - 14(H)

RECOMMENDING TO THE CHAIRMAN OF THE PROFESSIONAL REGULATION COMMISSION, FOR HIS APPROVAL, THE AWARD OF CONTRACT FOR THE PROCUREMENT OF VARIOUS IT EQUIPMENT: LOT 1 FORTY-FOUR (44) UNITS OF LASER COLORED PRINTER TO BUSINESS MACHINES CORPORATION WITH TOTAL BID AMOUNT OF ONE MILLION EIGHT HUNDRED TWENTY-EIGHT THOUSAND FIVE HUNDRED EIGHT PESOS (Php1,828,508.00)

WHEREAS, by virtue of the published invitation to apply for eligibility and to bid through Public Bidding in the Professional Regulation Commission (PRC) website and in the Philippine Government Electronic Procurement System (PhilGEPS), and in the Bids and Awards Committee (BAC) Bulletin Board for the project: Procurement of Various IT Equipment: Lot 1 – Forty-Four (44) Units of Laser Colored Printer with approved budget of Two Million Two Hundred Eighty-Eight Thousand Pesos (Php2,288,000.00).

WHEREAS, on January 4, 2019 a pre-bid conference was held, to explain and clarify the bidding documents and to accommodate any inquiry which the bidders may have and was attended by five (5) prospective bidders namely: Link Network Solutions, Inc. (Link Network), Business Machines Corporation (BISMAC), Philcopy Corporation (Philcopy), The Value Systems Phils., Inc. (VSP), and Quartz Business Product Corporation (Quartz), only Quartz and BISMAC purchased the Bid Documents.

WHEREAS, on January 8, 2019 the BAC issued Bid Bulletin No. 1 for modification/amendment to the bidding documents (**Annex "A"**).

WHEREAS, on January 16, 2019, during the Submission and Opening of Bids, Quartz and BISMAC submitted their bids eligibility, technical and financial requirements.

WHEREAS, Section 30, Rule IX of the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184, known as the Government Procurement Reform Act requires that the preliminary examination of the bids be conducted by merely checking for the presence or absence of documentary requirements using a non-discretionary "pass/fail" criterion. If a bidder submits the required document, it shall be rated "passed" for the particular requirement. In this regard, bids that fail to include any requirement or are incomplete or patently insufficient shall be considered as "failed".

WHEREAS, during the opening and evaluation of bids, Quartz failed to Acknowledge the Section IV General Condition of the Contract as part of its Technical Documents and was given "failed" mark on the evaluation sheet, thus the BAC did not open its financial bid. Quartz was then given a period of three (3) days to file a Motion for Reconsideration (MR) but they failed to do so.

WHEREAS, on the other hand, BISMAC having passed the eligibility and technical evaluation, the BAC opened its financial bid requirement with bid amount of One Million Eight Hundred Twenty-Eight Thousand Five Hundred Eight Pesos (Php1,828,508.00), and was declared to be the Single Calculated Bidder and thus subjected to post-qualification.



WHEREAS, on January 25, 2019, a post-qualification was conducted at BISMAC's office located at Carson Bldg. Orense St. Guadalupe Nuevo, Makati City to verify, validate and ascertain all statements made in its Eligibility and Technical Bid Envelopes submitted during the opening of bids, including the additional requirements forwarded by the bidder.

WHEREAS, BISMAC passed the post-qualification was declared to be the Single Calculated and Responsive Bidder.

WHEREFORE, the **BIDS AND AWARDS COMMITTEE RESOLVES**, as it hereby **RESOLVED**, to recommend to the Chairman of the Professional Regulation Commission, for his approval, the award of contract for the **PROCUREMENT OF VARIOUS IT EQUIPMENT: LOT 1 FORTY-FOUR (44) UNITS OF LASER COLORED PRINTER** to **BUSINESS MACHINES CORPORATION** with the bid of **ONE MILLION EIGHT HUNDRED TWENTY-EIGHT THOUSAND FIVE HUNDRED EIGHT PESOS (Php1,828,508.00)**






