**KNOW ALL MEN BY THESE PRESENTS:**

This Contract of services is executed and entered into for all purposes and in all respects by and between

**PROFESSIONAL REGULATION COMMISSION-  
REGIONAL OFFICE XII (PRC RO-XII)**, an agency of the National Government, with regional address at Regional Government Center, Barangay Carpenter Hill, City of Koronadal, South Cotabato represented by its Regional Director, **ROTELO B. CABUGSA**;

-and-

**Davao One World Diagnostic Center, Inc. (One World)**, a corporation duly organized and existing under and by virtue of the laws of the Republic of the Philippines, with principal address at Km. 5, Guadalupe Village, Matina Crossing Brgy. Matina, Davao City represented herein by its CEO, **Ms. THERESA GOTAMCO**.

WITNESSETH

**WHEREAS**, PRC- RO XII invited bids for the Procurement of Service Provider for RT-PCR Test for Examination Personnel of PRC ROXII, and has accepted the bid of Davao One World Diagnostic Center Inc. for the supply of services in the sum **TWO MILLION TWO HUNDRED TEN THOUSAND FOUR HUNDRED PESOS (Php 2,210,400.00)** (hereinafter called "the Contract Price");

**WHEREAS**, upon evaluation and recommendation of the Bids and Awards Committee, and approval of the Regional Bids and Awards Committee Region 12 and approval of the Head of Procuring Entity (HOPE), **Davao One World Diagnostic Center, Inc.** was found to be the Single Calculated and Responsive Bidder for the project: Procurement of Service Provider for RT-PCR Test for Examination Personnel of PRC ROXII;

**NOW, THEREFORE**, for and in consideration of the foregoing premises and of the mutual obligations, duties and responsibilities, as well as the terms and conditions hereinafter set forth, PRC ROXII and Davao One World Diagnostic Center, Inc. the parties hereto have agreed as follows:

2. The following documents, herein attached shall be deemed to form part of this Agreement and be read and construed as follows:

  - C. The Special Conditions of the Contract under Section V of the Bidding Documents
  - D. The Schedule of Requirements under Section VI of the Bidding Documents
  - E. The Technical Specifications under Section VII of the Bidding Documents
  - F. The Performance Security
  - G. Omnibus Sworn Statement; and
  - H. Notice of Award

3. In consideration of the payments to be made by the PRC-ROXII, **DAVAO ONE WORLD DIAGNOSTIC CENTER, INC.**, hereby agrees to provide the services and to remedy defects therein in conformity, in all respects with the provisions of this Contract.
4. **PRC-ROXII** hereby covenants to pay the **DAVAO ONE WORLD DIAGNOSTIC CENTER, INC.**, in consideration of the provision of the services and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the contract.
