

**CONTRACT FOR THE
PROVISION OF SECURITY SERVICES
FOR THE PRC-LEGAZPI REGIONAL OFFICE**
CS-06-2019-18 (Amended) **June 4, 2019**

KNOW ALL MEN BY THESE PRESENTS:

This Contract made and entered into by and between:

PROFESSIONAL REGULATION COMMISSION – LEGAZPI REGIONAL OFFICE, an agency of the National Government, hereinafter referred to as “the Entity,” with office address at Regional Government Center Site, Rawis, Legazpi City, represented by its Regional Director, **DR. ELENITA L. TAN**;

-and-

HYDRO VISION SECURITY AGENCY, a sole proprietorship duly organized and existing under the laws of the Republic of the Philippines, hereinafter referred to as “the Supplier” with principal address at No. 37-1 Jacinto Street, Barangay Bañadero Pob, Legazpi City herein represented by its Proprietor, **MR. FELIX RULL VILLAFLORES, JR.**

WITNESSETH THAT:

WHEREAS, the Entity, Professional Regulation Commission Legazpi Regional Office, invited Bids for the Provision of Security Services for the PRC Legazpi Regional Office, herein referred to as “the Project”, and has accepted the Bid of the Supplier for the supply of security services in the sum of **EIGHT HUNDRED EIGHTY SIX THOUSAND SEVEN HUNDRED EIGHT PESOS and FIFTY SIX CENTAVOS (Php 886,708.56)**. (Hereinafter called “the Contract Price”);

WHEREAS, upon evaluation and recommendation of the Regional Bids and Awards Committee of PRC Legazpi City Regional Office, and as approved by the Regional Director, the Supplier was found to be the single calculated and responsive bidder for the Project;

NOW THEREFORE, for and in consideration of the above mentioned premises and of the mutual obligations, duties and responsibilities, as well as the terms and conditions hereinafter set forth, the Entity and the Supplier have agreed as follows:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents, herein attached as *Annexes “A” to “H”*, respectively, shall be deemed to form and be read and construed as part of this Agreement. viz:
 - a) the Bid Form and the Price Schedule submitted by the Supplier ;
 - b) the Schedule of Requirements acknowledged by the Supplier;
 - c) the Technical Specifications acknowledged by the Supplier;
 - d) the General Conditions of Contract;
 - e) the Special Conditions of Contract;
 - f) the Entity’s Notification of Award;
 - g) The Affidavit of Undertaking executed by the Supplier, and
 - h) The Supplier’s Secretary’s Certificate.
3. In consideration of the payments to be made by the Entity to the Supplier as hereinafter mentioned, the Supplier hereby agrees with the Entity to provide the

security services in conformity in all respects and purposes with the provisions of this Contract.

4. This Contract shall be valid for a term of one (1) year, effective from July 26, 2019 to July 25, 2020, subject to certain terms and conditions that may be mutually agreed by the parties, in accordance with the provisions of Republic Act No. 9184 otherwise known as "*Philippine Government Procurement Reform Act*," its Revised Implementing Rules and Regulations and related issuances.
