
WITNESSETH THAT:

WHEREAS, PRC invited Bids for the Provision of Security Services (2020 – 2021) for PRC Cagayan de Oro Regional Office X, and has accepted the Bid of **BWPSSI SECURITY AGENCY (Blackwater Philippines Security Solutions), Inc.** for the supply of goods and services in the sum of **ONE MILLION FORTY-SIX THOUSAND ELEVEN PESOS AND SEVENTEEN CENTAVOS ONLY (P1,046,011.17)**.



