RECOMMENDING TO THE OFFICER-IN-CHARGE REGIONAL DIRECTOR OF THE PROFESSIONAL REGULATION COMMISSION CAGAYAN DE ORO REGIONAL OFFICE X FOR HER APPROVAL, TO RESORT TO DIRECT CONTRACTING WITH COPYLANDIA OFFICE SYSTEMS CORPORATION (COPYLANDIA), FOR THE PROCUREMENT OF VARIOUS CONSUMABLES OF RISOGRAPH MACHINES WITH THE TOTAL BID AMOUNT OF TWO HUNDRED THIRTY-SEVEN THOUSAND FIVE HUNDRED NINETY PESOS (P 237,590.00)

WHEREAS, the Finance and Administrative Division (FAD) has submitted a request for the procurement of various consumables of Risograph machines, as follows:

WHEREAS, there is a need to purchase consumables for the above stated Risograph machines to maintain the smooth and orderly conduct of operation of the Regional Office.

WHEREAS, Section 48 of Republic Act No. 9184 and its Implementing Rules and Regulations provide that the procuring entity may resort to any of the alternative methods of procurement, provided that, in all instances, the procuring entity shall ensure that the most advantageous price for the Government is obtained.

WHEREAS, Section 50 of the IRR of R.A. No. 9184, among others, allows direct contracting or single source procurement under the following conditions:

"(a) Procurement of Goods of proprietary nature which can be obtained only from the proprietary source, i.e. when patents, trade secrets, and copyrights prohibit others from manufacturing the same item;
