RESOLUTION RECOMMENDING TO THE HEAD OF THE PROCURING ENTITY (HOPE) OF THE PROFESSIONAL REGULATION COMMISSION (PRC) XII THE AWARD OF THE CONTRACT FOR THE SUPPLY AND DELIVERY OF VARIOUS FURNITURE AND FIXTURE-REBID THROUGH SMALL VALUE PROCUREMENT UNDER SECTION 53.9 OF THE 2016 REVISED IMPLEMENTING RULES AND REGULATIONS OF REPUBLIC ACT NO. 9184, WITH AN APPROVED BUDGET CONTRACT OF SEVEN HUNDRED TEN THOUSAND PESOS (Php710, 000.00) ONLY.

WHEREAS, the invitation to apply for eligibility and to bid through Negotiated Procurement (Section 53.9 Small Value Procurement) was posted in the Philippine Government Electronic Procurement System (Philgeps), website of the Commission and at the Regional Bids and Awards Committee (RBAC) Bulletin Board for the Project: **Supply and Delivery of Various Furniture and Fixture – Rebid** with the Approved Budget for the Contract (ABC) of Seven Hundred Ten Thousand Pesos (Php710, 000.00), inclusive of all government charges.

WHEREAS, pursuant to Annex H, V, D, Item 8.b.ii of the 2016 Revised Implementing Rules and Regulations of RA No. 9184, the Bids and Awards Committee prepared and sent the Request for Quotation to at least three (3) suppliers, contractors or consultants of known qualifications;

WHEREAS, on December 21, 2020, the scheduled submission and opening of bids, four (4) bidders submitted their bid proposals and eligibility requirements namely: Wilcon Depot Inc., MCM Villamor Marketing Corporation, KCC Property Holdings, Inc., and KORONADAL COMMERCIAL CORPORATION (KCC Mall of Marbel).

WHEREAS, during evaluation of the bid documents, only **KCC Mall of Marbel** submitted the complete and valid eligibility requirements and met the minimum specification after the post-qualification with financial bid proposal of One Hundred Twenty-One Thousand Three Hundred Sixty-Five Pesos only (Php121,365.00) for the following:

Lot 4 – Seven (7) units of Junior Executive Office Chair with Bid Amount of Thirty-One Thousand and Four Hundred Sixty-Five pesos (Php31, 465.00)

Lot 11 – Twenty (20) units of Office Table with Bid Amount of Eighty-Nine Thousand and Nine Hundred pesos (Php89, 900.00)

WHEREAS, the bid quotation for Lot 1 is above ABC, Lot 2, 3 and 5 did not meet the minimum specification and no quotation was made for Lot 6-10.

WHEREFORE, the **REGIONAL BIDS AND AWARDS COMMITTEE RESOLVES**, as it hereby **RESOLVED**, to recommend the award of the contract for the project entitled **SUPPLY AND DELIVERY OF FURNITURE AND FIXTURE-REBID (LOT 4 AND 11)** for

PRC REGIONAL OFFICE XII TO **KCC MALL OF MARBEL (KORONADAL CITY)** with total bid amount of **One Hundred Twenty-One Thousand Three Hundred Sixty-Five Pesos (Php121,365.00)** only **INCLUSIVE OF ALL TAXES**.
