RECOMMENDING TO THE CHAIRMAN OF THE PROFESSIONAL REGULATION COMMISSION FOR HIS APPROVAL THE AWARD OF THE CONTRACT FOR THE SUPPLY AND DELIVERY OF PRC PRE-PRINTED ID CARDS AND CONSUMABLES WITH FREE USE OF BRAND NEW ID CARD PRINTING EQUIPMENT FOR CALENDAR YEAR 2019 TO ALLCARD INC. WITH THE TOTAL BID OF SEVENTEEN MILLION ONE HUNDRED THIRTY FOUR THOUSAND PESOS (PHP17,134,000.00)

WHEREAS, the Bids and Awards Committee (BAC) caused the posting of the invitation to apply for eligibility and to bid through Public Bidding in the Professional Regulation Commission (PRC) website and in the Philippine Government Electronic Procurement System (PhilGEPS), and in the BAC Bulletin Board for the project: Supply and Delivery of PRC Pre-printed ID Cards and Consumables with Free Use of Brand New ID Card Printing Equipment for Calendar Year (CY) 2019 for an Approved Budget for the Contract of Seventeen Million Two Hundred Thirty Eight Thousand Pesos (Php17,238,000.00).

WHEREAS, on December 14, 2018 a pre-bid conference was held to explain and clarify the bidding documents and to accommodate any inquiry which the bidders may have, which was attended by two (2) prospective bidders namely, Allcard Inc. and Commerce Asia.

WHEREAS, on December 27, 2018, during the deadline for submission and Opening of Bids, only Allcard, Inc. participated and submitted its eligibility, technical and financial proposal.

WHEREAS, Section 30, Rule IX of the Revised Implementing Rules and Regulations of Republic Act No. 9184, known as the Government Procurement Reform Act, requires that the preliminary examination of bids be conducted by merely checking for the presence or absence of documentary requirements using a non-discretionary "pass/fail" criterion. If a bidder submits the required document, it shall be rated "passed" for that particular requirement. In this regard, bids that fail to include any requirement or are incomplete or patently insufficient shall be considered as "failed".

WHEREAS, Allcard, Inc. having passed the eligibility and technical evaluation, the BAC opened its financial proposal with the bid of Seventeen Million One Hundred Thirty Four Thousand Pesos (Php17,134,000.00). Hence, Allcard, Inc. was declared to be the Single Calculated Bidder and was subjected to post-qualification on December 28, 2018 at 48th Floor, One San Miguel Avenue Building, San Miguel Avenue cor. Shaw Boulevard, Pasig City.

WHEREAS, on December 28, 2018, during the post qualification, the BAC verified, validated and ascertained all statement made, and documents submitted by the bidder during the submission and opening of bids in its Eligibility, Technical and Financial Envelopes including the additional documentary requirements that will be submitted by the said bidder during post-qualification.

WHEREAS, on January 18, 2019, the BAC has visited the manufacturing plant of Allcard, Inc. at Lot 3, Blk. 17 E. Rodriguez Jr. Ave., cor. Titan St., Acropolis Subd., Bagumbayan, D3, Quezon City and conducted an inspection on the printing facilities of the bidder.

WHEREAS, Allcard Inc. passed the post-qualification, was declared to be the Single Calculated and Responsive Bidder.

WHEREFORE, the BIDS AND AWARDS COMMITTEE RESOLVES, as it hereby RESOLVED, to recommend to the Chairman of the Professional Regulation Commission, for his approval, the award of contract for the SUPPLY AND DELIVERY OF PRC PRE-PRINTED ID CARDS AND CONSUMABLES WITH FREE USE OF BRAND NEW ID CARD PRINTING EQUIPMENT FOR CALENDAR YEAR 2019 TO ALLCARD INC. WITH THE TOTAL BID AMOUNT OF SEVENTEEN MILLION ONE HUNDRED THIRTY FOUR THOUSAND PESOS (PHP17,134,000.00).
