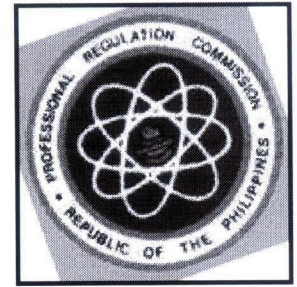

Where: K = 10 for a contract duration of one year or less, 15 for a contract duration of more than one year up to two years, and 20 for a contract duration of more than two years.  <b>The values of the bidder's current assets and current liabilities shall be based on the data submitted to the BIR, through its Electronic Filing and Payment System (EFPS).</b>

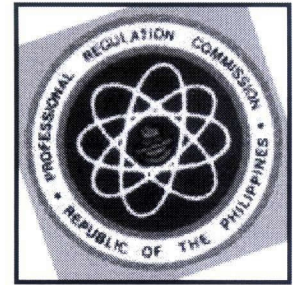

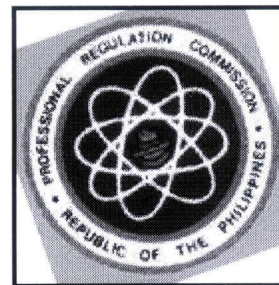
12.1(a) (i)	<p>"No other acceptable proof of registration is recognized."</p> <p>The original Certificate of Registration shall be submitted.</p> <p><i>In case of an amendment of the name of the Corporate, bidders must submit the Certificate of Filing of amended Articles of Incorporation certifying therein the new name of the entity, SEC certification as to the amendment of the corporate name, if applicable, as well as a certificate of good standing.</i></p>
12.1(a) (ii)	<p>Valid and current Mayor's Permit/municipal license where the prospective Bidder's principal office is located.</p> <p><i>In exceptional cases where the LGU concerned has not yet released the Mayor's Permit, Bidders in lieu of the valid Mayor's Permit may submit a substantial proof of renewal of Mayor's Permit, such as Official Receipt of payment.</i></p>

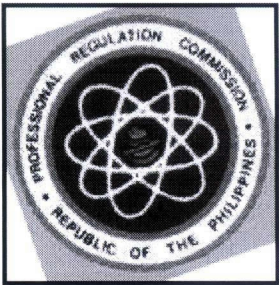

16.3	Payment shall be made in Philippine peso.
17.1	Bids will be valid for one hundred twenty (120) calendar days from the date of Opening Of Bids.
18.1	<b><u>The bid security shall be limited to Bid Securing Declaration or Manager's Check in the following amount:</u></b>  1. No percentage required, if the bid security is Bid Securing Declaration; or  2. The amount of <u>₱24,046.90</u> , if bid security is in Manager's check.
18.2	The bid security shall be valid until the Lowest Calculated and Responsive Bidder has posted the appropriate Performance Security.
18.5 (a) (iv-xii)	<i>The following as additional grounds for forfeiture of bid security:</i> <ol style="list-style-type: none"><li>1. Submission of eligibility requirements containing false information or falsified documents.</li><li>2. Submission of bids that contain false information or falsified documents, or the concealment of such information in the bids in order to influence the outcome of eligibility screening or any other stage of the public bidding.</li><li>3. Allowing the use of one's name, or using the name of another for purposes of public bidding.</li><li>4. Withdrawal of a bid, or refusal to accept an award, or enter into contract with the Government without justifiable cause, after the Bidder had been adjudged as having submitted the Lowest Calculated and Responsive Bid.</li><li>5. Refusal or failure to post the required performance security within the prescribed time.</li><li>6. Refusal to clarify or validate in writing its bid during post-qualification within a period of seven (7) calendar days from receipt of the request for clarification.</li><li>7. Any documented unsolicited attempt by a bidder to unduly influence the outcome of the bidding in his favor.</li><li>8. Failure of the potential joint venture partners to enter into the joint venture after the bid is declared as successful.</li><li>9. All other acts that tend to defeat the purpose of the competitive bidding, such as habitually withdrawing from bidding, submitting late Bids or patently insufficient bid, for at least three (3) times within a year, except for valid reasons.</li></ol>





