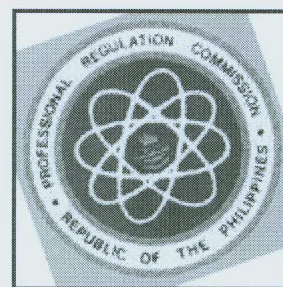

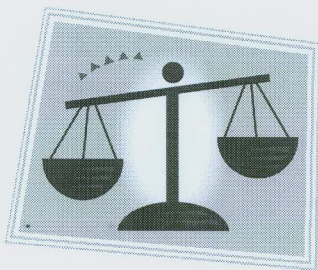

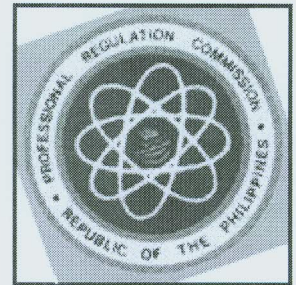
ITB Clause	
1.1	The Procuring Entity is the <b>Professional Regulation Commission</b>
1.2	The name of the Project is <b>Procurement of Application Software and Support Premium for Firewall Device with a Total Approved Budget For The Contract (ABC) of One Million Tw Hundred Ninety-Seven Thousand Pesos (Php1,297,000.00).</b> The identification or reference number of the Contract is: <b>ITB No. 018-015</b>
2	The Funding Source is the Government of the Philippines (GOP) through the <b>General Appropriations Act of 2018.</b>
5.1	Bidding is restricted to eligible bidders as provided by ITB clause 5.1
5.2	None of the circumstances mentioned in the <b>ITB</b> Clause exists in this Project. Foreign bidders, except those falling under <b>ITB</b> Clause 5.2 (b), may not participate in this Project.
5.4	The Bidder must have completed, within the period specified in the Invitation to Bid and <b>ITB</b> Clause 12.1 a (iii), a single contract that is similar to this Project, equivalent to at least fifty percent (50%) of the ABC. For this purpose, similar contracts shall refer to <b>contracts for the Procurement of Application Software and Support Premium for Firewall Device.</b>
5.5	<b>The Bidder must submit a computation of its Net Financial Contracting Capacity (NFCC), which must be at least equal to the ABC to be bid, calculated as follows:</b>  NFCC = [(Current assets minus current liabilities) (15)] minus the value of all outstanding or uncompleted portions of the projects under going contracts, including awarded contracts yet to be started coinciding with the contract for this Project.  The values of the domestic bidder's current assets and current liabilities shall be based on the latest Audited Financial Statements submitted to the BIR- for purposes of computing the foreign bidders' NFCC, the value of the current assets and current liabilities shall be based on their Audited Financial Statement prepared in accordance with international financial reporting standards.

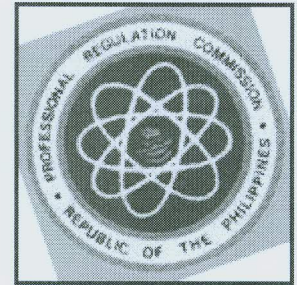

Those enumerated under BDS Clause 12.1 (a) (i-vi) shall form part of the Eligibility and Technical; Financial Requirements.

12.1(a) (i)	<p>"No other acceptable proof of registration is recognized."</p> <p>The original/certified true copy of Certificate of Registration shall be submitted.</p> <p><i>In case of an amendment of the name of the Corporate, bidders must submit the Certificate of Filing of amended Articles of Incorporation certifying therein the new name of the entity, SEC certification as to the amendment of the corporate name, if applicable, as well as a certificate of good standing.</i></p>
	<p>Original/certified true copy of Articles of Incorporation and By-laws:</p> <p>The bidder must submit its Articles of Incorporation and By-laws which were originally submitted with the SEC under and all of its previous Corporate name and the succeeding amendments or series of amendments, if any.</p> <p><i>In case of an amendment of the name of Corporate, bidders must submit Certificate of Filing of amended Articles of Incorporation certifying therein the new name of the entity, SEC certification as to the amendment of the corporate name, if applicable, as well as a certificate of good standing.</i></p>

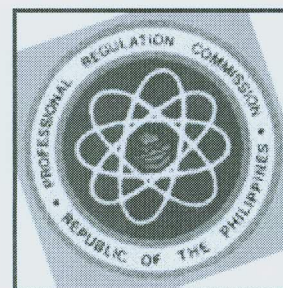
13.2 (a)	The <b>ABC</b> is <b>ONE MILLION TWO HUNDRED NINETY-SEVEN THOUSAND PESOS (Php1,297,000.00)</b> , <i>inclusive of all taxes</i> .  <i>Any bid with a financial component exceeding this amount shall not be accepted and will be disqualified.</i>
15.4 (a) (iii)	"No incidental services are required."
15.4 (b)	"No incidental services are required."
16.1 (b)	The bid prices for Goods supplied from outside the Philippines shall be quoted in Philippine peso.
16.3	Payment shall be made in Philippine peso.
17.1	Bids will be valid for one hundred twenty (120) calendar days from the date of Opening Of Bids.
18.1	The bid security shall be in the form of a Bid Securing Declaration, or any of the following forms and amounts: <ol style="list-style-type: none"><li>1. The amount of not less than <b>Php</b> _____ [<b>2% of ABC</b>], if bid security is in cash, cashier's/manager's check, bank draft/guarantee or irrevocable letter of credit; or</li><li>2. The amount of not less than <b>Php</b> _____ [<b>5% of ABC</b>] if bid security is in Surety Bond.</li></ol>
18.2	The bid security shall be valid until the Lowest Calculated and Responsive Bidder has posted the appropriate Performance Security.
18.5 (a) (iv-xii)	<i>The following as additional grounds for forfeiture of bid security:</i> <ol style="list-style-type: none"><li>1. Submission of eligibility requirements containing false information or falsified documents.</li><li>2. Submission of bids that contain false information or falsified documents, or the concealment of such information in the bids in order to influence the outcome of eligibility screening or any other stage of the public bidding.</li><li>3. Allowing the use of one's name, or using the name of another for purposes of public bidding.</li><li>4. Withdrawal of a bid, or refusal to accept an award, or enter into contract with the Government without justifiable cause, after the Bidder had been adjudged as having submitted the Lowest Calculated and Responsive Bid.</li><li>5. Refusal or failure to post the required performance security within the prescribed time.</li><li>6. Refusal to clarify or validate in writing its bid during post-qualification within a period of seven (7) calendar days from receipt of the request for clarification.</li><li>7. Any documented unsolicited attempt by a bidder to unduly influence the outcome of the bidding in his favor.</li><li>8. Failure of the potential joint venture partners to enter into the joint venture after the bid is declared as successful.</li><li>9. All other acts that tend to defeat the purpose of the competitive bidding, such as habitually withdrawing from bidding, submitting late Bids or patently insufficient bid, for at least three (3) times within a year, except for valid reasons.</li></ol>
