BIDS AND AWARDS COMMITTEE Resolution No. 2019 -30(A)

RECOMMENDING TO THE CHAIRMAN OF THE PROFESSIONAL REGULATION COMMISSION, FOR HIS APPROVAL, THE AWARD OF CONTRACT FOR THE ENGAGEMENT OF A CERTIFYING BODY FOR A THIRD PARTY AUDIT CERTIFICATION UNDER ISO 9001:2015 QUALITY MANAGEMENT SYSTEM FOR THE CENTRAL OFFICE AND THREE (3) REGIONAL OFFICES OF THE PROFESSIONAL REGULATION COMMISSION TO CERTIFICATION INTERNATIONAL PHILIPPINES, INC. WITH TOTAL BID AMOUNT OF ONE MILLION FIVE HUNDRED NINE THOUSAND SEVEN HUNDRED SIXTY PESOS (Php1,509,760.00)

WHEREAS, by virtue of the published invitation to apply for eligibility and to bid through Public Bidding in the Professional Regulation Commission (PRC) website and in the Philippine Government Electronic Procurement System (PhilGEPS), and in the Bids and Awards Committee (BAC) Bulletin Board for the project: Engagement of a Certifying Body for a Third Party Audit Certification under ISO 9001:2015 Quality Management System for the Central Office and Three (3) Regional Offices of the Professional Regulation Commission with approved budget of One Million and Five Hundred Twenty-Six Thousand Pesos (Php1,526,000.00).

WHEREAS, on May 28, 2019, a pre-bid conference was held to explain and clarify the bidding documents and to accommodate any inquiry which the bidders may have. This was attended only by Certification International Philippines, Inc. (CIP) which thereafter purchased the Bid Documents.

WHEREAS, on June 3, 2019, the BAC issued Bid Bulletin No. 1 for modification/amendment to the bidding documents (Annex "A").

WHEREAS, on June 11, 2019, CIP submitted its bids eligibility, technical and financial requirements during the Submission and Opening of Bids with bid amount of One Million Five Hundred Nine Thousand Seven Hundred Sixty Pesos (Php1,509,760.00).

WHEREAS, Section 30, Rule IX of the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184, known as the Government Procurement Reform Act requires that the preliminary examination of the bids be conducted by merely checking for the presence or absence of documentary requirements using a non-discretionary "pass/fail" criterion. If a bidder submits the required document, it shall be rated "passed" for the particular requirement. In this regard, bids that fail to include any requirement or are incomplete or patently insufficient shall be considered as "failed".

WHEREAS, CIP having passed the eligibility and technical evaluation during evaluation of bid was declared as the Single Calculated Bidder and was subjected to post-qualification.

WHEREAS, on June 18, 2019, a post-qualification was conducted at the Office of Assistant Commissioner located at PRC 2nd Floor Main Building, P. Paredes St., Sampaloc, Manila to verify, validate and ascertain all statements made in its Eligibility

and Technical Bid Envelopes submitted during the opening of bids, including the additional requirements forwarded by the bidder.

WHEREAS, CIP having passed the post-qualification was declared to be the Single Calculated and Responsive Bidder.

WHEREFORE, the BIDS AND AWARDS COMMITTEE RESOLVES, as it hereby RESOLVED, to recommend to the Chairman of the Professional Regulation Commission, for his approval, the award of contract for the ENGAGEMENT OF A CERTIFYING BODY FOR A THIRD PARTY AUDIT CERTIFICATION UNDER ISO 9001:2015 QUALITY MANAGEMENT SYSTEM FOR THE CENTRAL OFFICE AND THREE (3) REGIONAL OFFICES OF THE PROFESSIONAL REGULATION COMMISSION to CERTIFICATION INTERNATIONAL PHILIPPINES, INC. with the bid of ONE MILLION FIVE HUNDRED NINE THOUSAND SEVEN HUNDRED SIXTY PESOS (Php1,509,760.00).
