RECOMMENDING TO THE CHAIRMAN OF THE PROFESSIONAL REGULATION COMMISSION, FOR HIS APPROVAL, THE AWARD OF CONTRACT FOR THE PROVISION OF SECURITY SERVICES IN CENTRAL AND NCR OFFICES FOR CY 2022 TO ABC-RMO SECURITY & INVESTIGATION AGENCY INC. WITH A TOTAL BID AMOUNT OF SEVEN MILLION FIVE HUNDRED FIFTEEN THOUSAND SEVEN HUNDRED THIRTEEN PESOS AND SIXTY FOUR CENTAVOS (Php7,515,713.64)

WHEREAS, the Bids and Awards Committee (BAC) caused the posting of the invitation to apply for eligibility and to bid through Public Bidding in the Professional Regulation Commission (PRC) website, the Philippine Government Electronic Procurement System (PhilGEPS), and BAC Bulletin Board for the project: Provision of Security Services in Central and NCR Offices for CY 2022 with an approved budget for the contract of Seven Million Eight Hundred Seventy Six Thousand Seven Hundred Four Pesos and Sixty Nine Centavos (Php7,876,704.69).

WHEREAS, on 12 November 2021, a pre-procurement conference was held to discuss the terms of reference prepared and submitted by the end user for the abovementioned project before the preparation of the bidding documents.

WHEREAS, on 25 November 2021, only ABC-RMO purchased the Bidding Documents.

WHEREAS, on 26 November 2021, a pre-bid conference via video conferencing was held to explain and clarify the bidding documents and to accommodate any inquiry which the bidders may have. This was attended by one (1) prospective bidder, ABC-RMO Security & Investigation Agency Inc. (ABC-RMO).

WHEREAS, on 29 November 2021, the BAC issued Bid Bulletin No. 1, providing the Revised Bid Securing Declaration (BSD) and new schedule of deadline for submission and opening of bids. The notice was posted in PhilGEPS, PRC Website and BAC Bulletin Board.

WHEREAS, Section 30, Rule IX of the Revised Implementing Rules and Regulations of Republic Act No. 9184 (RA 9184), known as the Government Procurement Reform Act, requires that the preliminary examination of bids be conducted by merely checking for the presence or absence of documentary requirements using a non-discretionary "pass/fail" criterion.

WHEREAS, during the submission and opening of bids on 10 December 2021, ABC-RMO passed the eligibility and technical evaluation, with the financial bid quotation of Seven Million Five Hundred Fifteen Thousand Seven Hundred Thirteen Pesos and Sixty Four Centavos (Php7,515,713.64).

WHEREAS, ABC-RMO was declared as the Single Calculated Bidder and was subjected to Post-Qualification.

WHEREAS, on 14 December 2021, during the post-qualification, conducted at the BAC Conference Room, PRC Central Office, located at the 4th Floor of the PRC Annex Building, ABC-RMO presented the original copies of the eligibility and technical documents submitted during the opening of bids including the additional requirements for post qualification.

WHEREAS, ABC-RMO having passed the post-qualification, was declared to be the Single Calculated and Responsive Bidder.

WHEREFORE, the **BIDS AND AWARDS COMMITTEE RESOLVES**, as it hereby **RESOLVED**, to recommend to the Chairman of the Professional Regulation Commission, for his approval, the award of contract for the **PROVISION OF SECURITY SERVICES IN CENTRAL AND NCR OFFICES FOR CY 2022** to **ABC-RMO SECURITY & INVESTIGATION AGENCY INC.** with the bid amount of **SEVEN MILLION FIVE HUNDRED FIFTEEN THOUSAND SEVEN HUNDRED THIRTEEN PESOS AND SIXTY FOUR CENTAVOS (Php7,515,713.64)**.
