**Resolution No. 2021 - 84(A)**

**RECOMMENDING TO THE CHAIRMAN OF THE PROFESSIONAL REGULATION COMMISSION, FOR HIS APPROVAL, THE AWARD OF CONTRACT FOR THE PROVISION OF JANITORIAL SERVICES IN CENTRAL AND NCR OFFICES FOR CY 2022 TO D' TRIUMPH CLEANERS AND ALLIED SERVICES, INC. WITH A TOTAL BID AMOUNT OF EIGHT MILLION TWO HUNDRED FIFTY-EIGHT THOUSAND FOUR HUNDRED EIGHTY-TWO PESOS AND TWENTY CENTAVOS (Php8,258,482.20)**

**WHEREAS**, the Bids and Awards Committee (BAC) caused the posting of the invitation to apply for eligibility and to bid through Public Bidding in the Professional Regulation Commission (PRC) website, the Philippine Government Electronic Procurement System (PhilGEPS), and BAC Bulletin Board for the project: Provision of Janitorial Services in Central and NCR Offices for CY 2022 with an approved budget for the contract of Eight Million Four Hundred Thirty Two Thousand Eight Hundred Ninety Six Pesos and Ninety Two Centavos (Php8,432,896.92).

**WHEREAS**, on 12 November 2021, a pre-procurement conference was held to discuss the terms of reference prepared and submitted by the end user for the abovementioned project before the preparation of the bidding documents.

**WHEREAS**, on 26 November 2021, a pre-bid conference via video conferencing was held to explain and clarify the bidding documents and to accommodate any inquiry which the bidders may have. This was attended by one (1) prospective bidder, D' Triumph Cleaners and Allied Services, Inc. (D' Triumph).

**WHEREAS**, on 29 November 2021, the BAC issued Bid Bulletin No. 1, providing the total number of janitors and number of working days indicated in Annex A and Annex B of Section VII. Technical Specification, respectively. The BAC also provided a revised Bid Securing Declaration (BSD) and new schedule of the deadline for submission and opening of bids. The notice was posted in PhilGEPS, PRC Website, and BAC Bulletin Board.

**WHEREAS**, on 29 November 2021, only D' Triumph purchased the Bidding Documents.

**WHEREAS**, Section 30, Rule IX of the Revised Implementing Rules and Regulations of Republic Act No. 9184 (RA 9184), known as the Government Procurement Reform Act, requires that the preliminary examination of bids be conducted by merely checking for the presence or absence of documentary requirements using a non-discretionary "pass/fail" criterion.

**WHEREAS**, during the submission and opening of bids on 10 December 2021, D' Triumph passed the eligibility and technical evaluation, with the financial bid quotations of Eight Million Two Hundred Fifty-Eight Thousand Four Hundred Eighty-Two Pesos and Twenty Centavos (Php8,258,482.20).



**WHEREAS**, D' Triumph was declared as the Single Calculated Bidder and was subjected to Post-Qualification.

**WHEREAS**, on 14 December 2021, during the post-qualification, conducted at the BAC Conference Room, PRC Central Office, located at the 4<sup>th</sup> Floor of the PRC Annex Building, D' Triumph presented the original copies of the eligibility and technical documents submitted during the opening of bids including the additional requirements for post qualification.

**WHEREAS**, during the continuation of post-qualification on 15 December 2021, D' Triumph having passed the post-qualification, was declared to be the Single Calculated and Responsive Bidder.

**WHEREFORE**, the **BIDS AND AWARDS COMMITTEE RESOLVES**, as it hereby **RESOLVED**, to recommend to the Chairman of the Professional Regulation Commission, for his approval, the award of contract for the **PROVISION OF JANITORIAL SERVICES IN CENTRAL AND NCR OFFICES FOR CY 2022** to **D' TRIUMPH CLEANERS AND ALLIED SERVICES, INC.** with the bid amount of **EIGHT MILLION TWO HUNDRED FIFTY EIGHT THOUSAND FOUR HUNDRED EIGHTY TWO PESOS AND TWENTY CENTAVOS (Php8,258,482.20)**.
