Resolution No. 2021 - 92

RECOMMENDING TO THE CHAIRMAN OF THE PROFESSIONAL REGULATION COMMISSION, FOR HIS APPROVAL, THE AWARD OF CONTRACT FOR THE PROCUREMENT OF COURIER SERVICES FOR 2022 TO WIDE WIDE WORLD EXPRESS CORPORATION WITH A TOTAL BID AMOUNT OF ONE MILLION FIVE HUNDRED TWENTY-FIVE THOUSAND SIX HUNDRED PESOS (Php1,525,600.00)

WHEREAS, the Bids and Awards Committee (BAC) caused the posting of the invitation to apply for eligibility and to bid through Public Bidding in the Professional Regulation Commission (PRC) website, the Philippine Government Electronic Procurement System (PhilGEPS), and BAC Bulletin Board for the project: Procurement of Courier Services for 2022 with an approved budget for the contract of Two Million Three Hundred Thousand Pesos (Php2,300,000.00).

WHEREAS, on 12 November 2021, at 10:30 am, a pre-procurement conference was held to discuss the terms of reference prepared and submitted by the end user for the abovementioned project before the preparation of the bidding documents.

WHEREAS, on 26 November 2021, a pre-bid conference via video conferencing was held to explain and clarify the bidding documents and to accommodate any inquiry which the bidders may have. This was attended by Two (2) prospective bidders namely: Airspeed International Corporation and 2GO Group, Inc.

WHEREAS, on 29 November 2021, the BAC issued Bid Bulletin No. 1, providing the approximate kilogram per region as basis for the computation of bids, copy of the Revised Bid Securing Declaration, and new schedule of deadline for submission and opening of bids. The notice was posted in PhilGEPS, PRC Website and BAC Bulletin Board.

WHEREAS, on 9 December 2021, the BAC issued Bid Bulletin No. 2 in regard to the Technical Specification, re-scheduling of the deadline for submission and opening of bids, and was also posted in PhilGEPS, PRC Website and BAC Bulletin Board.

WHEREAS, on 14 December 2021, only Wide Wide World Express Corporation (W Express) purchased the Bidding Documents.

WHEREAS, Section 30, Rule IX of the Revised Implementing Rules and Regulations of Republic Act No. 9184 (RA 9184), known as the Government Procurement Reform Act, requires that the preliminary examination of bids be conducted by merely checking for the presence or absence of documentary requirements using a non-discretionary "pass/fail" criterion.

WHEREAS, during the submission and opening of bids on 20 December 2021, W Express passed the eligibility and technical evaluation, with the financial bid quotations of One Million Five Hundred Twenty-Five Thousand Six Hundred Pesos (Php1,525,600.00).

WHEREAS, W Express was declared as the Single Calculated Bidder and was subjected to Post-Qualification.


WHEREAS, on 22 December 2021, during the post-qualification, conducted at the BAC Conference Room, PRC Central Office, located at the 4th Floor of the PRC Annex Building, W Express presented the original copies of the eligibility and technical documents submitted during the opening of bids including the additional requirements for post qualification.


WHEREAS, W Express having passed the post-qualification, was declared to be the Single Calculated and Responsive Bidder.

WHEREFORE, the **BIDS AND AWARDS COMMITTEE RESOLVES**, as it hereby **RESOLVED**, to recommend to the Chairman of the Professional Regulation Commission, for his approval, the award of contract for the **PROCUREMENT OF COURIER SERVICES FOR 2022** to **WIDE WIDE WORLD EXPRESS CORPORATION** with the bid amount of **ONE MILLION FIVE HUNDRED TWENTY-FIVE THOUSAND SIX HUNDRED PESOS (Php1,525,600.00)**.


