RECOMMENDING TO THE CHAIRMAN OF THE PROFESSIONAL REGULATION COMMISSION, FOR HIS APPROVAL, THE AWARD OF CONTRACT FOR THE PROCUREMENT OF MANPOWER SERVICE PROVIDER FOR CY 2022 - REBID TO LSERV CORPORATION WITH A TOTAL BID AMOUNT OF SIX MILLION THREE HUNDRED NINE THOUSAND EIGHT HUNDRED EIGHTY PESOS AND FORTY THREE CENTAVOS (Php6,309,880.43)

WHEREAS, the Bids and Awards Committee (BAC) caused the posting of the invitation to apply for eligibility and to bid through Public Bidding in the Professional Regulation Commission (PRC) website, the Philippine Government Electronic Procurement System, and BAC Bulletin Board for the project: Procurement of Manpower Service Provider for CY 2022 - Rebid with an approved budget for the contract of Six Million Three Hundred Fifty Four Thousand Six Hundred Eighty One Pesos and Fifty Two Centavos (Php6,354,681.52).

WHEREAS, on 31 January 2022, a pre-procurement conference was held to discuss the terms of reference prepared and submitted by the end user for the abovementioned project before the preparation of the bidding documents.

WHEREAS, on 14 February 2022, a pre-bid conference via video conferencing was held to explain and clarify the bidding documents and to accommodate any inquiry which the bidders may have. This was attended by two (2) prospective bidders, namely; LSERV Corporation (LSERV) and Omniworx, Inc.

WHEREAS, on 15 February 2022, only LSERV purchased the Bidding Documents.

WHEREAS, Section 30, Rule IX of the Revised Implementing Rules and Regulations of Republic Act No. 9184 (RA 9184), known as the Government Procurement Reform Act, requires that the preliminary examination of bids be conducted by merely checking for the presence or absence of documentary requirements using a non-discretionary "pass/fail" criterion.

WHEREAS, during the submission and opening of bids on 28 February 2022, LSERV passed the eligibility and technical evaluation, with the financial bid quotations of Six Million Three Hundred Nine Thousand Eight Hundred Eighty Pesos and Forty Three Centavos (Php6,309,880.43).

WHEREAS, LSERV was declared as the Single Calculated Bidder and was subjected to Post-Qualification.


WHEREAS, on 02 March 2022, during the post-qualification, conducted at the BAC Conference Room, PRC Central Office, located at the 4th Floor of the PRC Annex Building, LSERV presented the original copies of the eligibility and technical documents submitted during the opening of bids including the additional requirements for post qualification.


WHEREAS, during the continuation of post-qualification on 03 March 2022, LSERV having passed the post-qualification, was declared to be the Single Calculated and Responsive Bidder.

WHEREFORE, the BIDS AND AWARDS COMMITTEE RESOLVES, as it hereby RESOLVED, to recommend to the Chairman of the Professional Regulation Commission, for his approval, the award of contract for the PROCUREMENT OF MANPOWER SERVICE PROVIDER FOR CY 2022-REBID to LSERV CORPORATION with the bid amount of SIX MILLION THREE HUNDRED NINE THOUSAND EIGHT HUNDRED EIGHTY PESOS AND FORTY THREE CENTAVOS (PHP6,309,880.43).


