Resolution No. 2022 - 07

RECOMMENDING TO THE CHAIRMAN OF THE PROFESSIONAL REGULATION COMMISSION, FOR HIS APPROVAL, THE AWARD OF CONTRACT FOR THE PROCUREMENT OF MANPOWER SERVICE PROVIDER FOR REGIONAL OFFICES TO LSERV CORPORATION WITH A TOTAL BID AMOUNT OF THIRTY-ONE MILLION THIRTY-FIVE THOUSAND ONE HUNDRED FORTY PESOS AND SIXTY-FIVE CENTAVOS (Php31,035,140.65)

WHEREAS, the Bids and Awards Committee (BAC) caused the posting of the invitation to apply for eligibility and to bid through Public Bidding in the Professional Regulation Commission (PRC) website, the Philippine Government Electronic Procurement System, and BAC Bulletin Board for the project: Procurement of Manpower Service Provider for Regional Offices with an approved budget for the contract of Thirty-One Million One Hundred Sixty-Four Thousand Nine Hundred Ninety-Four Pesos and Eighty-One Centavos (Php31,164,994.81).

WHEREAS, on 15 February 2022, a pre-procurement conference was held to discuss the terms of reference prepared and submitted by the end user for the abovementioned project before the preparation of the bidding documents.

WHEREAS, on 11 March 2022, a pre-bid conference via video conferencing was held to explain and clarify the bidding documents and to accommodate any inquiry which the bidders may have. This was attended by two (2) prospective bidders, namely; LSERV Corporation (LSERV) and Omniworx, Inc., however, only LSERV purchased the Bidding Documents.

WHEREAS, during the submission and opening of bids on 24 March 2022, LSERV passed the eligibility and technical evaluation, was declared as the Single Calculated Bidder and was subjected to Post-Qualification, with the financial bid quotations of Thirty-One Million Thirty-Five Thousand One Hundred Forty Pesos and Sixty-Five Centavos (Php31,035,140.65).

WHEREAS, Section 30, Rule IX of the Revised Implementing Rules and Regulations of Republic Act No. 9184, known as the Government Procurement Reform Act requires that the preliminary examination of bids be conducted by merely checking for the presence or absence of documentary requirements using a non-discretionary "pass/fail" criterion. If a bidder submits the required document, it shall be rated "passed" for that particular requirement. In this regard, bids that fail to include any requirement or are incomplete or patently insufficient shall be considered as "failed".

WHEREAS, the post-qualification was conducted on 25 March 2022 and on 28 March 2022, at the BAC Conference Room, located at the 4th Floor of the PRC Annex Building and via videoconferencing, the original copies of the eligibility and technical documents submitted during the opening of bids was presented, including the additional requirements for submission during post qualification.

WHEREAS, LSERV having complied with all the documentary requirements, was declared to be the Single Calculated and Responsive Bidder.

WHEREFORE, the BIDS AND AWARDS COMMITTEE RESOLVES, as it hereby RESOLVED, to recommend to the Chairman of the Professional Regulation Commission, for his approval, the award of contract for the PROCUREMENT OF MANPOWER SERVICE PROVIDER FOR REGIONAL OFFICES to LSERV CORPORATION with the total bid amount of THIRTY-ONE MILLION THIRTY-FIVE THOUSAND ONE HUNDRED FORTY PESOS AND SIXTY-FIVE CENTAVOS (PHP31,035,140.65).
