BIDS AND AWARDS COMMITTEE Resolution No. 2022 - 21(A)

RECOMMENDING TO THE CHAIRMAN OF THE PROFESSIONAL REGULATION COMMISSION, FOR HIS APPROVAL, THE AWARD OF CONTRACT FOR THE SUPPLY AND DELIVERY OF TWO HUNDRED THIRTY-FOUR (234) SETS OF ALL IN ONE DESKTOP COMPUTER BUNDLED WITH UNINTERRUPTIBLE POWER SUPPLY TO JONECO TECH MARKETING CORP. WITH A TOTAL BID AMOUNT OF TEN MILLION FIVE HUNDRED FIFTY-THREE THOUSAND FOUR HUNDRED PESOS (Php10,553,400.00)

WHEREAS, the Bids and Awards Committee (BAC) caused the posting of the invitation to apply for eligibility and to bid through Public Bidding in the Professional Regulation Commission (PRC) website, the Philippine Government Electronic Procurement System (PhilGEPS), and BAC Bulletin Board for the project: Supply and Delivery of Two Hundred Thirty-Four (234) Sets of All In One Desktop Computer Bundled with Uninterruptible Power Supply with an approved budget for the contract of Eleven Million Seven Hundred Thousand Pesos (Php11,700,000.00).

WHEREAS, on March 15, 2022, a pre-procurement conference was held to discuss the terms of reference prepared and submitted by the end user for the abovementioned project before the preparation of the bidding documents.

WHEREAS, on April 5, 2022 a pre-bid conference via video conferencing was held to explain and clarify the bidding documents and to accommodate any inquiry which the bidders may have. This was attended by five (5) prospective bidders, Masangkay Computer Center, Microgenesis Business Systems, Integrated Computer Systems Inc. (Integrated Computer), Trends and Technologies, Inc. and Quartz Business Products Corp. Only Integrated Computer and Joneco Tech Marketing Corp. (Joneco) purchased the Bidding Documents.

WHEREAS, On April 7, 2022, the BAC issued Bid Bulletin No. 1 (Annex "A") reflecting the modification/amendment to the bidding document as a result of the pre-bid conference. On April 12, 2022 BAC issued Bid Bulletin No. 2 (Annex "B") for the change on the date of Submission and Opening of bids from April 19, 2022 to April 21, 2022 due to non-availability of quorum in compliance with Office Order No. 299 dated April 8, 2022 Series of 2022. On April 13, 2022, the BAC issued Bid Bulletin No. 3 (Annex "C") reflecting the modification on the Invitation to Bid Item No. 5 the applicable fee for the Bidding Documents.

WHEREAS, Section 30, Rule IX of the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184, known as the Government Procurement Reform Act requires that the preliminary examination of the bids be conducted by merely checking for the presence or absence of documentary requirements using a non-discretionary "pass/fail" criterion. If a bidder submits the required document, it shall be rated "passed" for the particular requirement. In this regard, bids that fail to include any requirement or are incomplete or patently insufficient shall be considered as "failed".

WHEREAS, on April 21, 2022, during the submission and opening of bids, two bidder submitted their respective bidding document namely: Joneco and Integrated Computer. The BAC, using a non-discretionary "pass/fail" criterion. Integrated Computer was given afailed mark for failure to submit its Audited Financial Statement. Hence, Integrated Computer was given three (3) calendar days to file for Motion for Reconsideration (MR). Integrated Computer stated that they will no longer file for MR.

WHEREAS, Joneco passed the eligibility and technical evaluation, and its bid was opened and its bid proposal is in the amount of Ten Million Five Hundred Fifty-Three Thousand Four Hundred Pesos (Php10,553,400.00). Thus, Joneco was declared as the Single Calculated Bidder and was subjected to Post-Qualification.

WHEREAS, on April 26, 2022, a post-qualification was conducted at the BAC Conference Room, PRC Central Office, located at the 4th Floor of the PRC Annex Building. Joneco presented the original copies of the eligibility and technical documents submitted during the opening of bids, including the additional requirements for post qualification.

WHEREAS, Joneco having passed the post-qualification, was declared to be the Single Calculated and Responsive Bidder.

WHEREFORE, the BIDS AND AWARDS COMMITTEE RESOLVES, as it hereby RESOLVED, to recommend to the Chairman of the Professional Regulation Commission, for his approval, the award of contract for the SUPPLY AND DELIVERY OF TWO HUNDRED THIRTY-FOUR (234) SETS OF ALL IN ONE DESKTOP COMPUTER BUNDLED WITH UNINTERRUPTIBLE POWER SUPPLY TO JONECO TECH MARKETING CORP. with the bid amount of TEN MILLION FIVE HUNDRED FIFTY-THREE THOUSAND FOUR HUNDRED PESOS (Php10,553,400.00).




