**DECLARATION OF FAILURE OF BIDDING FOR THE PROCUREMENT OF  
VARIOUS CONTINUOUS FORM WITH A TOTAL APPROVED BUDGET FOR THE  
CONTRACT OF THREE HUNDRED THOUSAND THREE HUNDRED ELEVEN PESOS  
(PHP300,311.00)**

**WHEREAS**, the invitation to apply for eligibility and to bid through Competitive Bidding was posted in the website of the Commission, at the Bids and Awards Committee (BAC) Bulletin Board, and in the Philippine Government Electronic Procurement System (PhilGEPS) for the project: Procurement of Various Continuous Form with an approved budget for the contract of Three Hundred Thousand Three Hundred Eleven Pesos (Php300,311.00) only.

**WHEREAS**, on April 20, 2022, Apex Office Supplies and Equipment Trading (Apex) purchased the bidding documents.

**WHEREAS**, on April 22, 2022, the BAC issued Bid Bulletin No. 1 reflecting the re-scheduling of the pre-bid conference and opening of bids.

**WHEREAS**, on April 27, 2022, a Pre-Bid Conference via videoconferencing was held to explain and clarify the bidding documents and to accommodate any inquiry which the bidder may have. This was attended by only one bidder, Apex.

**WHEREAS**, on April 29, 2022, the BAC issued Bid Bulletin No. 2 reflecting the modification/amendment to the bidding document as a result of the pre-bid conference.

**WHEREAS**, during the opening of bids on May 11, 2022, held at the PRC Conference Room, 4<sup>th</sup> Floor, PRC Annex Bldg., no bidder submitted its eligibility and technical requirements.

**WHEREAS**, Section 35, Rule X of the 2016 Revised Implementing Rules and Regulations (IRR) provides for the authority of the BAC to declare a failure of bidding in cases where no bids are received, to wit:

**Section 35. Failure of Bidding**

35.1 The BAC shall declare the bidding a failure when:

- a) **No bids are received;**
- b) All prospective bidders are declared ineligible;
- c) All bids fail to comply with all the bid requirements or post-qualification, or x xxx (Emphasis supplied)

**WHEREAS**, Section 35. 2 of the same IRR provides for the steps and procedures that the BAC should take in case of failure of bidding; x x x to wit:

35.2. In order to determine the reason for the failed bidding, the BAC shall conduct a mandatory review and evaluation of the terms, conditions, and specifications in the Bidding Documents, including its cost estimates.

WHEREFORE, the **BIDS AND AWARDS COMMITTEE RESOLVES**, as it hereby **RESOLVED**, to **DECLARE A FAILURE OF BIDDING FOR THE PROCUREMENT OF VARIOUS CONTINUOUS FORM** with a total approved budget for the contract of **THREE HUNDRED THOUSAND THREE HUNDRED ELEVEN PESOS (PHP300,311.00)**. Consequently, the BAC shall conduct a re-bidding with re-advertisement and/or posting of said procurement project.
