**Resolution No. 2022 - 63(A)**

**RECOMMENDING TO THE CHAIRMAN OF THE PROFESSIONAL REGULATION COMMISSION, FOR HIS APPROVAL, THE AWARD OF CONTRACT FOR THE SUPPLY, DELIVERY, INSTALLATION, CONFIGURATION, AND TESTING OF DATABASE FIREWALL TO FIBERCOM TELECOM PHILS., INC. WITH A TOTAL BID AMOUNT OF FOUR MILLION NINE HUNDRED SIXTY-EIGHT THOUSAND FORTY-NINE PESOS AND NINETY-FIVE CENTAVOS (Php4,968,049.95)**

**WHEREAS**, the Bids and Awards Committee (BAC) caused the posting of the invitation to apply for eligibility and to bid through Public Bidding in the Professional Regulation Commission (PRC) website, the Philippine Government Electronic Procurement System (PhilGEPS), and BAC Bulletin Board for the project: Supply, Delivery, Installation, Configuration, and Testing of Database Firewall with an approved budget for the contract of Five Million Pesos (Php5,000,000.00).

**WHEREAS**, on May 31, 2022, a pre-procurement conference was held to discuss the terms of reference prepared and submitted by the end user for the abovementioned project before the preparation of the bidding documents.

**WHEREAS**, on June 28, 2022 BAC issued Bid Bulletin No. 1 (Annex "A") re-scheduling a Pre-Bid Conference from June 30, 2022 to July 4, 2022 in compliance with Office Order No. 637 on Suspension of Work on June 30, 2022.

**WHEREAS**, on July 4, 2022 a pre-bid conference via video conferencing was held to explain and clarify the bidding documents and to accommodate any inquiry which the bidders may have. This was attended by two (2) prospective bidders namely: One Commerce (Int'l.) Corporation and Fibercom Telecom Phils., Inc. (Fibercom). Only Fibercom purchased the Bidding Documents.

**WHEREAS**, On July 4, 2022, the BAC issued Bid Bulletin No. 2 (Annex "B") reflecting the modification/amendment to the bidding document as a result of the pre-bid conference.

**WHEREAS**, Section 30, Rule IX of the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184, known as the "Government Procurement Reform Act", requires that the preliminary examination of the bids be conducted by merely checking for the presence or absence of documentary requirements using a non-discretionary "pass/fail" criterion. If a bidder submits the required document, it shall be rated "passed" for the particular requirement. In this regard, bids that fail to include any requirement or are incomplete or patently insufficient shall be considered as "failed".

**WHEREAS**, on July 13, 2022, during the submission and opening of bids, only Fibercom submitted its bidding document. Upon evaluation, Fibercom passed the eligibility and technical evaluation, and its bid was opened and its bid proposal is in the amount of Four Million Nine Hundred Sixty-Eight Thousand Forty-Nine Pesos and Ninety-Five Centavos (Php4,968,049.95).



Thus, Fibercom was declared as the Single Calculated Bidder and was subjected to Post-Qualification.

**WHEREAS**, on July 15, 2022, a post-qualification was conducted at the BAC Conference Room, PRC Central Office, located at the 4<sup>th</sup> Floor of the PRC Annex Building. Fibercom presented the original copies of the eligibility and technical documents submitted during the opening of bids, including the additional requirements for post qualification. However, Fibercom was not able to present the original copy of End-user's acceptance and/or Official Receipts of their Single Largest Completed Contract and the Latest income and Business Tax Returns. Thus, the BAC gave Fibercom until July 18, 2022 to present the same.

**WHEREAS**, on July 18, 2022, on continuation of post-qualification, Fibercom was able to present and submit a copy of their End-user's acceptance and/or Official Receipts of their Single Largest Completed Contract and the Latest income and Business Tax Returns. Fibercom having passed the post-qualification, was declared to be the Single Calculated and Responsive Bidder.


**WHEREFORE**, the **BIDS AND AWARDS COMMITTEE RESOLVES**, as it hereby **RESOLVED**, to recommend to the Chairman of the Professional Regulation Commission, for his approval, the award of contract for the **SUPPLY, DELIVERY, INSTALLATION, CONFIGURATION, AND TESTING OF DATABASE FIREWALL TO FIBERCOM TELECOM PHILS., INC. WITH A TOTAL BID AMOUNT OF FOUR MILLION NINE HUNDRED SIXTY-EIGHT THOUSAND FORTY-NINE PESOS AND NINETY-FIVE CENTAVOS (Php4,968,049.95).**
