**DECLARATION OF FAILURE OF BIDDING FOR ENGAGEMENT OF A CERTIFYING  
BODY FOR A THIRD PARTY AUDIT FOR RE-ASSESSMENT OF CERTIFICATION  
UNDER ISO 9001:2015 QUALITY MANAGEMENT SYSTEM FOR THE  
PROFESSIONAL REGULATION COMMISSION – CENTRAL OFFICE WITH A TOTAL  
APPROVED BUDGET FOR THE CONTRACT OF FIVE HUNDRED SIXTY-SIX  
THOUSAND SIX HUNDRED SIXTY-SEVEN PESOS (P566,667.00)**

**WHEREAS**, the invitation to apply for eligibility and to bid through Competitive Bidding was posted in the website of the Commission, at the Bids and Awards Committee (BAC) Bulletin Board, and in the Philippine Government Electronic Procurement System (PhilGEPS) for the project: Engagement of a Certifying Body for a Third Party Audit for Re-Assessment of Certification under ISO 9001:2015 Quality Management System for the Professional Regulation Commission – Central Office with an approved budget for the contract of Five Hundred Sixty-Six Thousand Six Hundred Sixty-Seven pesos only (P566,667.00).

**WHEREAS**, on June 29, 2022, a Pre-Bid Conference via videoconferencing was held to explain and clarify the bidding documents and to accommodate any inquiry which the bidder may have. This was attended by only one bidder, TÜV SÜD PSB Philippines Inc.

**WHEREAS**, during the opening of bids on July 12, 2022, held at the PRC Conference Room, 4<sup>th</sup> Floor, PRC Annex Bldg., and via videoconferencing. no bidder submitted its eligibility and technical requirements.

**WHEREAS**, Section 35, Rule X of the 2016 Revised Implementing Rules and Regulations (IRR) provides for the authority of the BAC to declare a failure of bidding in cases where no bids are received, to wit:

**Section 35. Failure of Bidding**

35.1 The BAC shall declare the bidding a failure when:

- a) **No bids are received;**
- b) All prospective bidders are declared ineligible;
- c) All bids fail to comply with all the bid requirements or post-qualification, or x xxx (Emphasis supplied)

**WHEREAS**, Section 35. 2 of the same IRR provides for the steps and procedures that the BAC should take in case of failure of bidding; x x x to wit:

35.2. In order to determine the reason for the failed bidding, the BAC shall conduct a mandatory review and evaluation of the terms, conditions, and specifications in the Bidding Documents, including its cost estimates.

WHEREFORE, the BIDS AND AWARDS COMMITTEE RESOLVES, as it hereby RESOLVED, to DECLARE A FAILURE OF BIDDING FOR THE ENGAGEMENT OF A CERTIFYING BODY FOR A THIRD PARTY AUDIT FOR RE-ASSESSMENT OF CERTIFICATION UNDER ISO 9001:2015 QUALITY MANAGEMENT SYSTEM FOR THE PROFESSIONAL REGULATION COMMISSION – CENTRAL OFFICE with a total approved budget for the contract of FIVE HUNDRED SIXTY-SIX THOUSAND SIX HUNDRED SIXTY-SEVEN PESOS (P566,667.00). Consequently, the BAC shall conduct a re-bidding with re-advertisement and/or posting of said procurement project.
