## BIDS AND AWARDS COMMITTEE Resolution No. 2022 - 107

RECOMMENDING TO THE CHAIRPERSON OF THE PROFESSIONAL REGULATION COMMISSION, FOR HER APPROVAL, THE AWARD OF CONTRACT FOR ENGAGEMENT OF A CERTIFYING BODY FOR A THIRD PARTY AUDIT FOR REASSESSMENT OF CERTIFICATION UNDER ISO 9001:2015 QUALITY MANAGEMENT SYSTEM FOR THE PROFESSIONAL REGULATION COMMISSION – CENTRAL OFFICE – REBID TO CERTIFICATION INTERNATIONAL PHILIPPINES, INC. WITH A TOTAL BID AMOUNT OF FIVE HUNDRED TWENTY-SIX THOUSAND AND FOUR HUNDRED PESOS (Php526,400.00)

WHEREAS, the Bids and Awards Committee (BAC) caused the posting of the invitation to apply for eligibility and to bid through Public Bidding in the Professional Regulation Commission (PRC) website, the Philippine Government Electronic Procurement System (PhilGEPS), and BAC Bulletin Board for the project: Engagement of a Certifying Body for a Third Party Audit for Re-Assessment of Certification under ISO 9001:2015 Quality Management System for the Professional Regulation Commission – Central Office- Rebid with an approved budget for the contract of Five Hundred Sixty-Six Thousand Six Hundred Sixty-Seven Pesos (P566,667.00).

**WHEREAS**, on August 9, 2022 a pre-bid conference via video conferencing was held to explain and clarify the bidding documents and to accommodate any inquiry which the bidders may have. This was attended only by Certification International Philippines Inc.

WHEREAS, Section 30, Rule IX of the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184, known as the "Government Procurement Reform Act", requires that the preliminary examination of the bids be conducted by merely checking for the presence or absence of documentary requirements using a non-discretionary "pass/fail" criterion. If a bidder submits the required document, it shall be rated "passed" for the particular requirement. In this regard, bids that fail to include any requirement or are incomplete or patently insufficient shall be considered as "failed".

WHEREAS, on August 23, 2022, during the submission and opening of bids, only Certification International Philippines Inc. purchased and submitted its bidding document. Upon evaluation, Certification International Philippines Inc. passed the eligibility and technical evaluation, and its bid was opened and its bid proposal is in the amount of Five Hundred Twenty-Six Thousand Four Hundred Pesos (Php526,400.00). Thus, Certification International Philippines Inc. was declared as the Single Calculated Bidder and was subjected to Post-Qualification.

**WHEREAS**, on August 24, 2022, a post-qualification was conducted at the BAC Conference Room, PRC Central Office, located at the 4<sup>th</sup> Floor of the PRC Annex Building. Certification International Philippines Inc. presented the original copies of the eligibility and technical documents submitted during the opening of bids.

WHEREAS, Certification International Philippines Inc. having passed the postqualification, was declared to be the Single Calculated and Responsive Bidder WHEREFORE, the BIDS AND AWARDS COMMITTEE RESOLVES, as it hereby RESOLVED, to recommend to the Chairperson of the Professional Regulation Commission, for her approval, the award of contract for the ENGAGEMENT OF A CERTIFYING BODY FOR A THIRD PARTY AUDIT FOR RE-ASSESSMENT OF CERTIFICATION UNDER ISO 9001:2015 QUALITY MANAGEMENT SYSTEM FOR THE PROFESSIONAL REGULATION COMMISSION - CENTRAL OFFICE - REBID TO CERTIFICATION INTERNATIONAL PHILIPPINES, INC. WITH A TOTAL BID AMOUNT OF FIVE HUNDRED TWENTY-SIX THOUSAND AND FOUR HUNDRED PESOS (Php526,400.00).
