Resolution No. ILO-2020-04

**RECOMMENDING TO THE HEAD OF PROCURING ENTITY OF THE
PROFESSIONAL REGULATION COMMISSION ILOILO REGIONAL OFFICE FOR
APPROVAL OF THE AWARD OF THE CONTRACT FOR THE PROVISION OF
SECURITY SERVICES (THREE GUARDS) TO PRC ILOILO REGIONAL OFFICE TO
BLUEWARRIORS SECURITY AGENCY FOR ONE (1) YEAR**

WHEREAS, a Request for Quotation through Negotiated Procurement was published in the PhilGEPS, PRC official website and the premises of the PRC Iloilo Regional Office on June 25, 2020 for the Procurement of Security Services (Three Guards) for the PRC Iloilo Regional Office with approved budget for the contract in the amount of **SEVEN HUNDRED EIGHTY THOUSAND PESOS (Php780,000.00)**, inclusive of VAT and all applicable taxes and fees.

WHEREAS, copies of the same Request for Quotation (RFQ No. 2020-004) were sent to three (3) prospective bidders: a) BLUEWARRIORS Security Agency, Inc., b) ROCKFORT Security Services, Inc., and c) SUREFIRE Security Agency, Inc.

WHEREAS, during the opening of bids on July 2, 2020, among the invited prospective bidders, only BLUEWARRIORS Security Agency, Inc. submitted eligibility and technical requirements, and price quotation/proposal.

WHEREAS, Section 30, Rule IX of the Revised Implementing Rules and Regulations of Republic Act No. 9184, known as the Government Procurement Reform Act requires that the preliminary examination of bids be conducted by merely checking for the presence or absence of documentary requirements using a no-discretionary "pass/fail" criterion. If a bidder submits the required document, it shall be rated "passed" for that particular requirement. In this regard, bids that fail to include any requirement or are incomplete or patently insufficient shall be considered "failed".

WHEREAS, BLUEWARRIORS Security Agency, Inc. having passed the eligibility and technical evaluation, the RBAC opened their financial bid proposal with a bid price of **SEVEN HUNDRED THIRTY-THREE THOUSAND FOUR HUNDRED SIXTY-TWO PESOS AND 92/100 (Php733,462.92)** and was declared to be the Single Calculated Bidder.

WHEREAS, on July 8, 2020, BLUEWARRIORS Security Agency, Inc. was subjected to post-qualification evaluation to ascertain the authenticity and validity of their eligibility and technical documents submitted during the opening of bid proposal.

WHEREAS, BLUEWARRIORS Security Agency, Inc. having passed the post qualification evaluation, was declared to be the Single Calculated and Responsive Bidder.

WHEREFORE, in view of the foregoing premises, the **REGIONAL BIDS AND AWARDS COMMITTEE RESOLVES**, as it hereby **RESOLVED**, to **RECOMMEND** to the Head of Procuring Entity of PRC Iloilo Regional Office, for his approval, the award of the

Contract to **BLUEWARRIORS Security Agency, Inc.**, for the provision of Security Services (Three Guards) to the PRC Iloilo Regional Office with the amount of **SEVEN HUNDRED THIRTY-THREE THOUSAND FOUR HUNDRED SIXTY-TWO PESOS AND 92/100 (Php733,462.92)** annually, or **SIXTY-ONE THOUSAND ONE HUNDRED TWENTY-ONE PESOS AND 91/100 (Php61,121.91)** monthly, inclusive of VAT and all applicable taxes and fees.
