**DECLARATION OF FAILURE OF BIDDING FOR PROJECT ENTITLED “SUPPLY
AND DELIVERY OF GENUINE HP TONERS”**

WHEREAS, a Request for Quotation through Small Value Procurement (Section 53.9 Small Value Procurement of RA 9184 IRR) was published in the PhilGEPS, PRC official website and posted at the premises of the PRC Iloilo Regional Office on November 20, 2020 for the Project: Supply and Delivery of Genuine HP Toners with an Approved Budget for the Contract (ABC) in the amount of **THREE HUNDRED FIFTY-EIGHT THOUSAND TWO HUNDRED TEN PESOS (Php358,210.00)**, inclusive of all taxes;

WHEREAS, Request for Quotation (RFQ No. 2020-009) were also sent to three (3) prospective suppliers, namely: a) PBT Technology Solutions, Inc. b) Silicon Valley Computer Group Phils, Inc. and c) Concept Computer Center;

WHEREAS, during the deadline for submission of bid documents on November 26, 2020, only PBT Technology Solutions, Inc. submitted their proposal;

WHEREAS, Section 30, Rule IX of the Revised Implementing Rules and Regulations of Republic Act No. 9184, known as the Government Procurement Reform Act requires that the preliminary examination of bids be conducted by merely checking for the presence or absence of documentary requirements using a no-discretionary “pass/fail” criterion. If a bidder submits the required document, it shall be rated “passed” for that particular requirement. In this regard, bids that fail to include any requirement or are incomplete or patently insufficient shall be considered “failed”.

WHEREAS, upon evaluation of requirements during the opening and evaluation of bid documents for the above-titled project on November 26, 2020, three o'clock in the afternoon at the PRC Iloilo Conference Room, PBT Solutions, Inc. was declared disqualified for failure to submit their Certification of Authorized Distributorship/Reseller from HP or Certificate of Authenticity of HP Products issued by Authorized Distributor/Reseller, and Omnibus Sworn Statement;

WHEREAS, Section 35 Rules X of the IRR provides for the authority of the BAC to declare a failure of bidding in cases where the bidders fail to comply with the bid requirements as prescribed, to wit:

Section 35. Failure of Bidding


35.1 The BAC shall declare the bidding a failure when:

- a) No bids are received;
- b) All prospective bidders are declared ineligible;
- c) **All bids fail to comply with all the bid requirements** or post-qualification, or x x x x (Emphasis Supplied)

WHEREFORE, in view of the foregoing premises, the **REGIONAL BIDS AND AWARDS COMMITTEE (RBAC) RESOLVES**, as it hereby **RESOLVED**, to **DECLARE A FAILURE OF BIDDING FOR THE PROJECT ENTITLED "SUPPLY AND DELIVERY OF GENUINE HP TONERS" (SECTION 53.9 SMALL VALUE PROCUREMENT)** with an approved budget for the contract of **THREE HUNDRED FIFTY-EIGHT THOUSAND TWO HUNDRED TEN PESOS (Php358,210.00)**, inclusive of all taxes. **RESOLVE FURTHER**, that the RBAC conduct a re-bidding with re-advertisement and/or posting of said project.
